The Scarborough Borough Council pursuant to arrangements made with the North Yorkshire County Council under Section 101 of the Local Government Act 1972 in exercise of the powers of the said County Council under Sections 1, 2, 3, 4, 32 to 39 and 45 to 49 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

1. The Borough of Scarborough (Prohibition of Waiting and Loading and Provision of Parking) (Consolidation) Order 2007 as amended shall have effect subject to the following amendments.
 - a. In Schedule 2 to the said Order, for the particulars relating to **Sea Cliff Road and Woodlands Drive**, Scarborough, there shall be added the particulars relating to those roads specified in the Schedule to this Order.
 - b. In Schedule 2 to the said Order, for the particulars relating to **Quay Street**, Scarborough, there shall be substituted the particulars relating to those roads specified in the Schedule to this Order.

2. This Order may be cited as "The Borough of Scarborough (Prohibition of Waiting and Loading and Provision of Parking) (Consolidation) Order 2007 (Amendment No.1) Order 2007 shall come into operation on 17 September 2007.
