The Scarborough Borough Council pursuant to arrangements made with the North Yorkshire County Council under Section 101 of the Local Government Act 1972 in exercise of the powers of the said County Council under Sections 1(1) and (2), 2(1), (2) and (3), 3(2) and 4(2), 35(1), 45 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), the Traffic Management Act 2004 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

- This Order shall come into operation on 3 April 2008 and shall be cited as the Borough of Scarborough (Prohibition of Waiting and Loading and Provision of Parking) Consolidation Order 2007 (Amendment No. 8) 2008.
- 2 This Order hereby amends all Orders specified in Schedule 1 of this Order.
- By this Order the Traffic Regulation Orders specified in Schedule 1 of this Order shall be modified as follows:

In Article 4.1 of this Order the following expressions shall be inserted:

"2004 Act" means the Traffic Management Act 2004.

"civil enforcement officer" means any officer of the Council who is authorised to supervise and control vehicles in the parking place and enforce the provisions of this Order pursuant to Section 76 of the 2004 Act and Section 63A of the 1984 Act;

- 4. Any reference to a "Parking Attendant" shall be removed and replaced by a reference to a "Civil Enforcement Officer".
- New Article 24 shall be inserted to include the following expressions:

Penalty Charge and Payment

- 24. Where a Motor Vehicle:
 - parks in contravention of the provisions of Sections 19 or 21 of the Road Traffic Act 1988 (prohibition of parking of HGVs on Verges, central reservations and footways), and (driving or parking on Cycle Tracks);
