

**THE SEDGEMOOR DISTRICT COUNCIL (OFF-STREET PARKING PLACES)
ORDER 2013 (AMENDMENT No. 2) ORDER 2017**

The Sedgemoor District Council (hereinafter referred to as "the Council") in accordance with Regulation 21(1)(b) of The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 and pursuant to arrangements made under Section 19 of the Local Government Act of 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with Somerset County Council ("the County Council") in exercise of the powers conferred by Sections 32, 33 & 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") (as amended by the Road Traffic Regulation (Parking) Act 1986) and Section 39(3) of the 1984 Act and the provisions of Part 6 of The Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order.

1. This Order shall come into operation on 1 August 2017 and may be cited as the "The Sedgemoor District Council (Off-Street Parking Places) Order 2013 (Amendment No. 2) Order 2017" hereinafter referred to as "this Order".
2. The provisions of The Sedgemoor District Council (Off-Street Parking Places) Order 2013 shall be amended by inserting into Schedule 1 (schedule of car parks) of that Order details of the following new car park;

3. The provisions of The Sedgemoor District Council (Off-Street Parking Places) Order 2013 shall be amended by inserting into Schedule 2 (plans of car parks) at no 22. the plan of Blake car park Bridgwater attached hereto
4. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

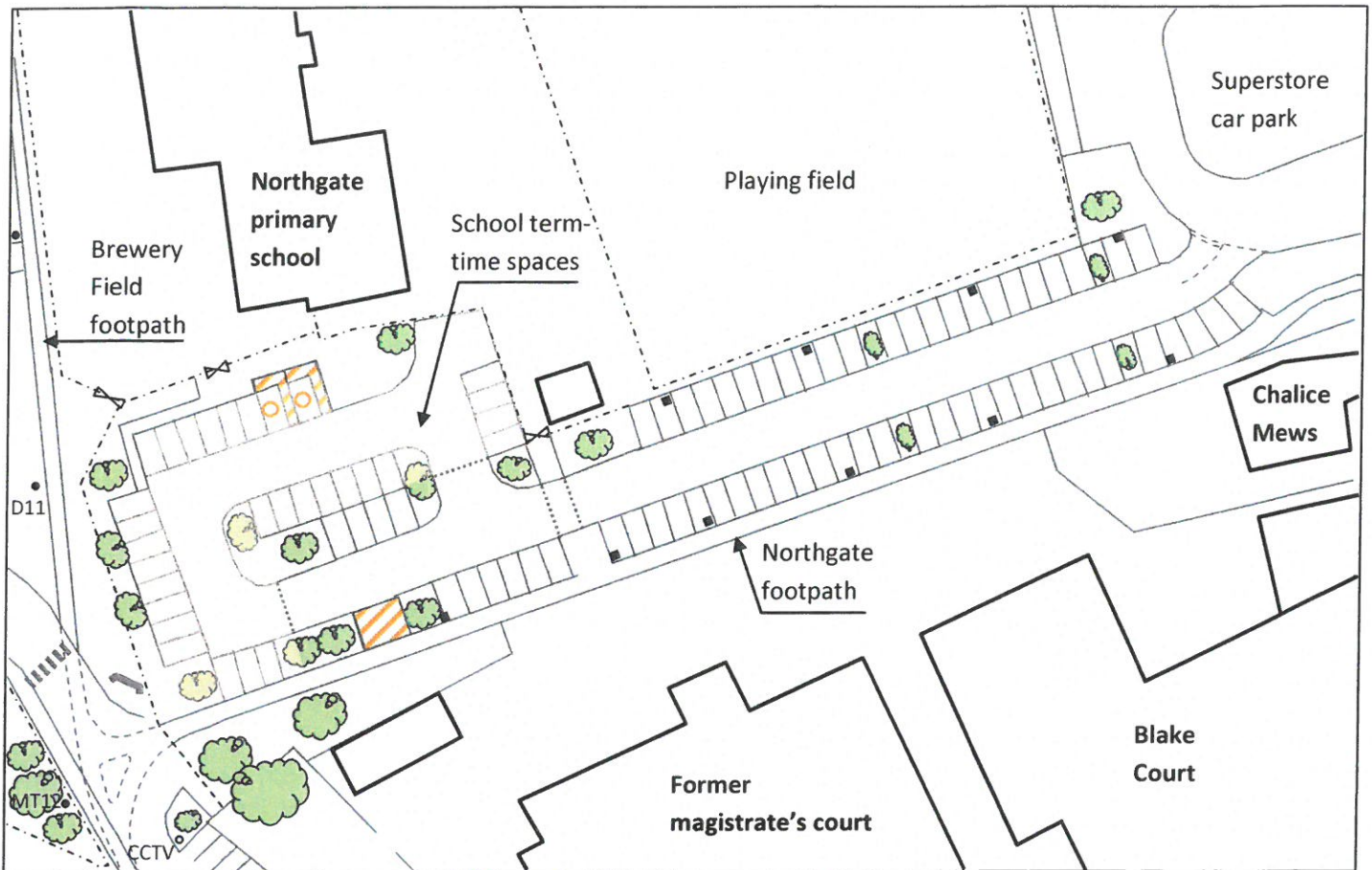
