The Sevenoaks District Council in exercise of the powers conferred by sections 32, 35 and 124 and Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, and with the consent of the Kent County Council, and after all consultation with the Chief Officer of the Police, hereby makes the following order:

Revocations, Modifications and Amendments

1. The effect of this order is to amend the Sevenoaks District Council (Off-Street Parking places) Order 2010 and all subsequent amendment Orders thereto as follows:
