Nothing in Article 7 of this Order shall apply to any hackney carriage licensed by Sevenoaks District Council pursuant to the Town Police Clauses Act 1847 and the Local Government (Miscellaneous Provisions) Act 1976 or the Traffic Management Act 2004 whilst waiting and available for immediate hire at a duly authorised taxi rank.
