### **ROAD TRAFFIC REGULATION ACT 1984**

## Citation, Revocations and Amendments

- 2. In this Order, the expression 'Order of 2013' means "The Kent County Council (Various Roads in the District of Sevenoaks) (Prohibition and Restriction of Waiting & Loading & Unloading & On-Street Parking Places) (Consolidation) Order 2013" and all subsequent amendment Orders thereto:
- 3. The effect of this Order is to amend the Order of 2013 as follows;
  - The items specified in the Schedule 1 to this Order is hereby revoked from Appendix 31 - West Kingsdown thereto
  - The items specified in the Schedule 2 to this Order is hereby added to Appendix ii) 31 - West Kingsdown thereto

- 4. Section 5 of the Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- This Order may shall come into operation on the 17th day of March 2023.
