**Road Traffic Regulation Act 1984** 

NOTICE is given that the Kent County Council hereby makes the above-named Order under Sections 81, 82, 84 and 124 of the Road Traffic Regulation Act 1984, the effect of which would be to: -

To reduce the current speed limit from 30MPH to 20MPH on the following lengths of roads in Swanley Village, Sevenoaks:-

**BEECHENLEA LANE** – From junction with Swanley Village Road for a distance of 320 metres in a southerly direction. **HIGHLANDS HILL** – From junction with School Lane for a distance of 350 metres in a westerly direction. **HOTHAM CLOSE** – For its entire length. **SCHOOL LANE** – From the northern boundary of Old Vicarage to its junction with Swanley Village Road. **SWANLEY VILLAGE ROAD** – From junction with School Lane to junction with Park Lane

The Order was made on 20 June 2024 and its provisions will come into effect on 21 June 2024.

A full statement of the Council's reasons for making the Order, a plan indicating the location and the effect and a copy of any other Orders which will be amended by the made Order may be examined at Kroner House, Eurogate Business Park, Ashford, Kent TN24 8XU by appointment booked through tro@kent.gov.uk or viewed online from 21 June 2024 at www.kent.gov.uk/highwaysconsultations

Anyone may, by application to the High Court within 6 weeks of the date of publication of this Notice, challenge the validity of the Orders or of any provision contained in them on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or any instrument made thereunder, or that there has been a failure to comply with any statutory requirement to the Orders.

**Road Traffic Regulation Act 1984** 

The Kent County Council as traffic authority hereby make the Order referred to above and as shown on the drawing accompanying this document for the following reasons :-

From 1 April 2013 Kent County Council become responsible for a number of Public Health functions. One of those was the health improvement for the population of Kent. In recent years the demand for the implementation of 20mph schemes had been increasing in response to both local and national campaigns, therefore Kent County Council are intending to implement 20mph Public Health Schemes in the following location, in Swanley Village, Sevenoaks.

In addition, the various restrictions are to:-

- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising
- For preserving or improving the amenities of the area through which the road runs.

#### **ROAD TRAFFIC REGULATION ACT 1984**

THE KENT COUNTY COUNCIL, acting as Local Traffic Authority and in exercise of its powers under Sections 81, 82, 84 and 124 of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act') as amended, and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

- 1. This Order shall come into operation on the 21st day of June 2024 and may be cited as "The Kent County Council (Various Roads, Sevenoaks) (Speed Limits) (Consolidation) (Amendment No.2) Order 2023" ('this Order').
- 2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Kent County Council (Various Roads, Sevenoaks) (Speed Limits) (Consolidation) Order 2023" ('the Order of 2023') shall have effect as though:
  - (a) Schedule 2 to the Order of 2023 is amended by the issue or replacement of the following Map Tiles:
