 - b) In Article 12 thereto for 'Nothing in Article 11, Article 11A, Article 11B, Article 11C, Article 11D or Article 11E' there was substituted 'Nothing in Article 11, Article 11A, Article 11B, Article 11C, Article 11D, Article 11E or Article 11F'.
 - c) In Schedule 3 thereto there were deleted items '7 Langsett Road (i) & (ii)' and '7A Middlewood Road'.
 - d) There was included a Schedule 3F:

SCHEDULE 3F BUS GATES

Between 7 a.m. and 7 p.m. on all days

1 LANGSETT ROAD

The south western side from its junction with the north western kerbline of Ripley Street to a point 48 metres north west of its junction with the western kerbline of Forbes Road.

2 MIDDLEWOOD ROAD

The north eastern side from a point 28 metres north west of its junction with the north western kerbline of Bradfield Road to a point 31 metres north west of that kerbline.

The north eastern side from a point 28 metres north west of its junction with the north western kerbline of Bradfield Road to a point 31 metres north west of that kerbline.
