

THE SHEFFIELD CITY COUNCIL
(BUS PRIORITY) (CONSOLIDATION) ORDER 1991
(AMENDMENT NO.42) ORDER 2007

The Sheffield City Council in exercise of its powers under Section 1(1), 2(1) and (2) and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. The Sheffield City Council (Bus Priority) (Consolidation) Order 1991 (as amended) shall have effect as though:
 - a) In Schedule 3 thereto item '1C Charles Street' was deleted.
 - b) In Schedule 3 thereto there were included the following items:

11A	Shortbrook Road	From its junction with Westfield Centre for a distance of 55 metres in a southerly direction.
11B	Streetfields	That length of the service road which extends from its junction with Springfields to its junction with Halfway Centre.
11C	Thorpe Drive/ Thorpe Green	That length of road which extends from its junction with Thorpe Drive to its junction with Thorpe Green.
 - c) In Article 11 thereto for 'Article 12, Article 12A, Article 12B, Article 13 and Article 13A' there was substituted 'Article 12, Article 12A, Article 12B, Article 12C, Article 13 and Article 13A'.
 - d) There was included an Article 12C:

12C	Nothing in Article 11 of this Order shall render it unlawful for a motorcycle to be in those lengths of road described in items '5A Furnival Road', '6B Infirmary Road', '7 Langsett Road', '7A Middlewood Road', '8 London Road', '9B Penistone Road' and '11 Southey Hill' in Schedule 3 thereto.

2. The following Orders are revoked in their entirety:
 - The South Yorkshire County Council
(Various Roads at Mosborough) (Prohibition of Driving) Order 1978;
 - The South Yorkshire County Council
(Service Roads in Halfway at Mosborough) (Prohibition of Driving) Order 1978;
 - The South Yorkshire County Council
(Shortbrook Road, Mosborough) (Prohibition of Driving) Order 1981.
3. This Order shall come into operation on the 1st day of April, 2007 and may be cited as The Sheffield City Council (Bus Priority) (Consolidation) Order 1991 (Amendment No.42) Order 2007.
