THE SHEFFIELD CITY COUNCIL (CONTROLLED ZONE) (PROHIBITION AND RESTRICTION OF WAITING AND ONE WAY TRAFFIC) (CONSOLIDATION) ORDER 1987

The Sheffield City Council in exercise of its powers under Section 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

PART I GENERAL

1. (1) In this Order

"disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations, 1975;

"disabled persons vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations, 1975;

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard specifications for Parking Discs (BS No.4631:1970), but coloured orange, and capable of showing the quarter hour period during which a period of waiting begins.

"goods" includes postal packets of any description and "delivering" or "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;

"restricted hours" means

(a) save as provided in (b) in relation to any restricted road specified in Schedule 1 Part I to this Order the period between 8.00 a.m. and 6.30 p.m. on any day not being a Sunday, Christmas Day or a Bank Holiday or than a Good Friday, and

(b) in relation to any restricted road specified in Schedule 1 Part II to this Order the whole twenty four hours of every day.

"restricted roads" means any road or part of road specified in Schedule 1 Part I and II to this Order provided that the expression "restricted road" shall not for the purpose of Articles 4, 5, 6 and 7 of this Order include any road or part of road designated as a parking place by the Sheffield City Council (Parking Places) (Consolidation) Order 1987.

"telegraphic line" has the same meaning as in the Telegraph Act 1878.

For the purpose of this Order a vehicle shall be regarded as displaying:-

(a) a disabled person's badge in the relevant position, when:-

(1) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen; and

1.

(ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle; and

- (b) a parking disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.
- For the purpose of this Order a vehicle shall be deemed to wait for a period of more than thirty minutes in the same place in any restricted road if any point in that road is below the vehicle or its load (if any) throughout a period exceeding thirty minutes, whether or not the vehicle is moved during that period.

PART II

WAITING RESTRICTIONS

Restriction of waiting of vehicles

3.

4. Save as provided in Articles 5, 6 and 7 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait in any restricted road during the restricted hours.

Exemptions from waiting restrictions

- 5. (1) Nothing in Article 4 of this Order shall prevent any person from causing or permitting a vehicle to wait on any restricted road:-
 - (a) for so long as may be necessary for the purpose of enabling any person to board or alight from the vehicle or to load thereon or unload therefrom his personal luggage;

provided that except where the said person is a disabled person no vehicle may so wait in the same place for longer than two minutes;

- (b) for so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any funeral, building operation, demolition or excavation in or adjacent to any restricted road, the removal of any obstruction to traffic in any restricted road, the maintenance, improvement or reconstruction of any restricted road, or the laying erection, alteration, removal or repair in or adjacent to any restricted road, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line or traffic sign;
- (c) if the vehicle is a vehicle used for fire brigade purposes or an ambulance, or any vehicle in the service of a local authority or police force in either case being used in pursuance of statutory powers and duties;
- (d) if the vehicle is a hackney carriage waiting upon any duly authorised cab rank;

- (e) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accident;
- (f) if the vehicle is in the service of or employed by the Post Office and is waiting while postal packets addressed to premises adjacent to that road are being unloaded from the vehicle, or having been unloaded therefrom, are being delivered or while postal packets are being collected from premises or posting boxes adjacent to that road;
- (g) if the vehicle is in the service of or employed by British Telecom and is in use in connection with the servicing of telephone kiosks adjacent to that road;
- for the purpose of loading or unloading the vehicle while the (h) vehicle is in actual use in connection with the removal of furniture from one office or dwellinghouse to another or the removal of furniture from such premises to a depository or such premises from a depository, except that no such vehicle shall wait for any such purpose during the period between 8.00 a.m. and 6.30 p.m. Monday to Saturday so far as such period falls within the restricted hours in any part of a restricted road specified in Schedule 1 Part III to this Order or during the period between 8.00 a.m. and 9.30 a.m. or the period between 4.30 p.m. and 6.30 p.m. Monday to Saturday so far as any such period falls within the restricted hours in any part of a restricted road specified in Schedule 1 Part IV to this Order unless notice is given twenty-four hours in advance to the police and their consent is obtained.
- 6. Nothing in Article 4 shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the sides of road referred to in that Article for a period of not exceeding 2 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same side of road on the same day).

Loading and unloading of goods

7. (1) Nothing in Article 4 of this Order shall render it unlawful to cause a vehicle to wait in any restricted road for so long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading a vehicle at premises adjoining that road:-

Provided that -

(a) no vehicle engaged in delivering or collecting goods or merchandise, including so far as a Bank is concerned, cash or other valuables or valuable securities, or being loaded or unloaded shall wait during the restricted hours in the same place in any restricted road for a period of more than thirty minutes or such longer period as a police constable in uniform may authorise and shall not wait again during the said hours on that length of road if a period of one hour has not elapsed since the termination of the last period of waiting;

- (b) no vehicle shall wait during the period between 8.00 a.m. and 6.30 p.m. Monday to Saturday so far as such period falls within the restricted hours in any part of a restricted road specified in Schedule 1 Part III to this Order for the purpose of delivering and collecting goods or merchandise or loading or unloading the vehicle;
- (c) no vehicle shall wait during the period between 8.00 a.m. and 9.30 a.m. or the period between 4.30 p.m. and 6.30 p.m. Monday to Saturday so far as any such period falls within the restricted hours in any part of a restricted road specified in Schedule 1 Part IV to this Order for the purpose of delivering and collecting goods or merchandise or loading or unloading the vehicle; and
- (d) nothing in the preceding provisos shall apply so as to restrict the loading or unloading of any vehicle while the vehicle is in actual use in connection with the collection or delivery of goods which cannot reasonably be loaded or unloaded outside the restricted hours provided that notice is given twenty-four hours in advance to the police and their consent is obtained.
- (2) Notwithstanding anything in paragraph (1) of this Article, the driver of a vehicle waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a police constable in uniform whenever such moving may be reasonably necessary for the purpose of preventing obstruction.

PART III ONE-WAY TRAFFIC

One-Way Streets

8. Save as provided in Article 9 of this Order, no person shall, except upon the direction of a police constable in uniform, cause any vehicle to proceed in any of the lengths of road specified in column 1 of Schedule 2 to this Order in a direction other than that specified in relation to that length of road in column 2 of the said Schedule.

Ch

4.

Exemption for road cleansing vehicles

- 9. Nothing in Article 6 of this Order shall apply to the driving of any mechanical road cleansing vehicle or of any vehicle used in connection with the clearing of snow by the Council.
- 10. The Orders specified in Schedule 3 to this Order are hereby revoked insofar as they relate to any of the lengths of road referred to in this Order.
- 11. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulation made or having effect as made under the Road Traffic Regulation Act 1984 as amended as aforesaid by or under any other enactment.

12. This Order shall come into operation on the 26th day of December 1987, and may be cited as the 'Sheffield City Council (Controlled Zone) (Prohibition and Restriction of Waiting and One-Way Traffic) (Consolidation) Order 1987.


