# THE SHEFFIELD CITY COUNCIL (CONSOLIDATION) (ON-STREET PARKING AND PROHIBITION OF WAITING) (OUTER AREA) ORDER 2008 (AMENDMENT NO. 31) ORDER 2011

The Sheffield City Council in exercise of its powers under Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) and (f) of the Road Traffic Regulation Act 1984 (c.27) ("the Act") and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part 111 of Schedule 9 to the Act, hereby make the following Order:-

- 1. The Sheffield City Council (Consolidation) (On-Street Parking and Prohibition of Waiting) (Outer Area) Order 2008 (as amended) shall have effect as though:
  - a) In Article 2 of Part 1 thereto for 'Initial Period' there was substituted the following item:-

'Initial Period' means the period beginning from the time the vehicle was first left in the parking place and ending on the expiration of the period indicated on the ticket issued with respect to that vehicle at the time when the vehicle was first left in the parking place.

b) In Part 111 Section A Table 5 there were included reference to the following Schedules:-

c) For Articles 5, 6, 7, 10, 11, 12, 13 and 19 of Part 111 Section A thereto there were substituted the following items:-

#### Amount of Parking Charges At Parking Places

- 5a) The driver of any vehicle which is left during the permitted hours in a parking place described in any Schedule listed in Column 1 of Table 5 to this Order may leave that vehicle for a period not exceeding 15 minutes without charge provided that:-
  - (i) the driver displays a ticket in compliance with Article 6 of this section; and
  - (ii) the ticket issuing machine relating to the said parking place has been adapted by the City Council to enable a ticket to be issued allowing a period of 15 minute parking without charge.
- 5b) Other than as described above in paragraph 5a) the parking charges for a vehicle left in a parking place described in the Schedules listed in Column 1 of Table 5 to this Order are as described in Columns 4 to 14 of that table relating to that Schedule in Column 1.

#### Display of Ticket

- 6a) The driver of a vehicle left in a parking place controlled by the display of a ticket from a ticket issuing machine shall display or cause to be displayed on the vehicle a ticket issued by a ticket issuing machine relating to that parking place, in accordance with the provisions of the following paragraph,
- 6b) The ticket referred to in the preceding paragraph shall be displayed in the vehicle, in respect of which it was issued, at all times during which the vehicle is left during the permitted hours in the parking place to the front or near side of the vehicle so that all details relating to the issue of the ticket and the time of expiry are readily visible from the front or nearside of the vehicle.

## Staying Longer than the Initial Period at Parking Places

7) If a vehicle is left in a parking place for longer than the initial period it shall be a contravention of this traffic regulation order and a penalty charge shall be payable.

#### Indications by Ticket Issuing Machines or by Ticket

- 10) The driver of any vehicle left in a parking place controlled by the display of a ticket from a ticket issuing machine shall display or cause to be displayed, in the manner specified in Article 6(b) of this section, a ticket issued by a ticket issuing machine relating to that parking place indicating:
  - a) that, other than as described in Article 5A of this section, the parking charge has been paid; and
  - b) the expiry of the initial period.

## Ticket Issuing Machine Indications as Evidence

11) If at any time while a vehicle is left in a parking place controlled by the issue of a ticket from a ticket issuing machine during the permitted hours no ticket issued by a ticket issuing machine relating to that parking place is displayed on that vehicle in accordance with Article 6 of this section, it shall be presumed, unless the contrary is proved, that the parking charge, if applicable, has not been paid.

## No additional coins to be inserted after payment of parking charge

12) No person shall insert in a ticket issuing machine any coins in addition to those coins inserted by way of payment for the initial period relating to that vehicle.

#### Interval before vehicle can be left again

- 13) Any vehicle which has taken away from a parking bay in any parking place described in any schedule specified in Column 1 of Table 5 to this order may not be left again in that parking place during the permitted hours, without complying with the no return period specified in Column 15 of Table 5 relating to that schedule.
- No person shall display on any vehicle left in a parking place during the permitted hours any ticket issued by a ticket issuing machine other than the ticket issued by a ticket issuing machine relating to that parking place in respect of that vehicle.

d) In Schedule 1.01C thereto for the item '806 Sharrow Vale Road – the north side (iv) there was substituted the following item:-

- (iv) From a point 130 metres east of its junction with the north-eastern kerb line of Hickmott Road for a distance of 83 metres in an easterly direction.

- (i) From its junction with the eastern kerb line of Robinson Road to a point 61 metres south east of its junction with the south eastern kerb line of Manor Lane.
- (ii) From a point 10 metres north west of its junction with the north western kerb line of Dovercourt Road to a point 70 metres north west of its junction with the north western kerb line of Wulfric Road excluding that part of the lay by situated between points 193 and 243 metres north west of the north western kerb line of Wulfric Road.

The south west side:-

- (i) From its junction with the north eastern kerb line of Stafford Road to a point 16 metres north west of the projected south eastern kerb line of Dovercourt Road.

- k) In Schedule 1.01C there were included the following items:-
