

THE SHEFFIELD CITY COUNCIL
(CONSOLIDATION) (ON-STREET PARKING AND PROHIBITION OF WAITING)
(CITY CENTRE CONTROLLED PARKING ZONE) ORDER 2008
(CONSOLIDATION AMENDMENT) ORDER 2015

The Sheffield City Council in exercise of its powers under Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) and (f) of the Road Traffic Regulation Act 1984 (c.27) ("the Act") and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. The Sheffield City Council (Consolidation) (On-street Parking and Prohibition of Waiting) (City Centre Controlled Parking Zone) Order 2008 and shall have effect as though:-

- a) In Part 1 section 2 for the definition of 'Restricted Hours' there was substituted the following definition:-

'Restricted Hours' means:

- (a) Save as provided in (b) in relation to any restricted road listed in Schedule 2.01 to this Order the period between 8:00am to 8:30pm on any day excluding Christmas Day or a Bank Holiday other than a Good Friday.
- (b) In relation to any restricted road listed in Schedule 1.01 to this Order the whole twenty four hours of every day.
- b) In Part III Parking Places and Bays Section A: Pay and Display for Article 1 there was substituted the following Article.
- 1) Each area on a highway in the City of Sheffield which is described as a designated parking place in any Schedule listed in Table 2 to this Order is designated as a parking place for the days and hours listed in Column 1 of Table 2.
- c) In Part III Parking Places and Bays Section A: Pay and Display for Article 5 there was substituted the following Article.

Amount of Parking Charges at Parking Places

- 5) The parking charges for a vehicle left in a parking place described in any Schedule listed in Table 2 to this Order are as described in Columns 2 to 5 in Table 2 to this Order in relation to the length of stay shown in Column 1 of Table 2.
- d) In Part III Parking Places and Bays Section A: Pay and Display for Table 2 - Pay and Display there was substituted the following table:-

- f) For the heading to Schedule 6.01 to the Order there shall be substituted the following:-

Schedule 6.01
Pay & Display Parking Mon – Sun 8:00am to 8:30pm
Excluding Christmas Day Or A Bank Holiday Other Than Good Friday

- g) For the heading to Schedule 6.02 to the Order there shall be substituted the following:-

Schedule 6.02
Pay & Display Parking Mon – Sun 8:00am to 8:30pm
Excluding Christmas Day Or A Bank Holiday Other Than Good Friday

- h) For the heading to Schedule 6.03 to the Order there shall be substituted the following:-

Schedule 6.03
Pay & Display Parking Mon – Sun 8:00am to 8:30pm
Excluding Christmas Day Or A Bank Holiday Other Than Good Friday

- i) For the heading to Schedule 6.04 to the Order there shall be substituted the following:-

Schedule 6.04
Pay & Display Parking Mon – Sun 8:00am to 8:30pm
Excluding Christmas Day Or A Bank Holiday Other Than Good Friday

2. This Order shall come into operation on the 13th day of July, 2015 and may be cited as The Sheffield City Council (Consolidation) (On-street Parking and Prohibition of Waiting) (City Centre Controlled Parking Zone) Order 2008 (Consolidated Amendment) Order 2015.
