## THE SHEFFIELD CITY COUNCIL (CONSOLIDATION) (ON-STREET PARKING AND PROHIBITION OF WAITING) (CITY CENTRE CONTROLLED PARKING ZONE) ORDER 2008 (AMENDMENT NO. 16) ORDER 2015

The Sheffield City Council in exercise of its powers under Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) and (f) of the Road Traffic Regulation Act 1984 (c.27) ("the Act") and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part 111 of Schedule 9 to the Act, hereby make the following Order:-

- The Sheffield City Council (Consolidation) (On-Street Parking and Prohibition of Waiting) (City Centre Controlled Parking Zone) Order 2008 (as amended) shall have effect as though:
  - a) In Schedule 1.01 thereto for the items '35 Carver Street the west side (iii) & (iv)' and '44 Charles Street Both sides (i)' there were substituted the following:-

35. Carver Street

The west side:

- (iii) From a point 38 metres south of the southern kerb line of West Street for a distance of 12 metres in a southerly direction.
- (iv) From a point 22 metres north west of the north western kerb line of Division Street and a point 15 metres south east of the south eastern kerb line of Division Street.

44. Charles Street

Both sides:

- (i) From a point 8 metres south east of its junction with the south eastern kerb line of Eyre Lane in a north westerly direction to its north western termination.

  - 7. The south west side of Carver Street from a point 70 metres north west of its junction with the north western kerb line of Division Street for a distance of 10 metres in a north westerly direction.
  - The south west side of Carver Street from a point 22 metres north west of its junction with the north western kerb line of Division Street for a distance of 43 metres in a north westerly direction.
- e) In Schedule 1.01 thereto the item '35 Carver Street the east side (i), (ii) and (iii)' was deleted.
- f) In Schedule 4.01 thereto the item '12 Carver Street the west side (iii)' was deleted.
- g) In Schedule 6.03 thereto the item '20 Charles Street' was deleted.
- h) In Schedule 10 thereto the items 'Burgess Street' and 'Carver Street (i) the east side' were deleted.

- i) In Schedule 11.05 thereto the item '1 Carver Street' was deleted.
