THE SHEFFIELD CITY COUNCIL (CONSOLIDATION) (ON-STREET PARKING AND PROHIBITION OF WAITING) (OUTER AREA) ORDER 2008 (AMENDMENT NO.49) ORDER 2012

The Sheffield City Council in exercise of its powers under Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) and (f) of the Road Traffic Regulation Act 1984 (c.27) ("the Act") and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part 111 of Schedule 9 to the Act, hereby make the following Order:-

- 1. The Sheffield City Council (Consolidation) (On-Street Parking and Prohibition of Waiting) (Outer Area) Order 2008 (as amended) shall have effect as though:
 - a) In Part II, Table 3 Permitted parking for any class of vehicle, there was included the following Schedule:-

- b) In Article 1 of PART IV Clearways for reference to the term 'wait' there was substituted the term 'stop'.
- c) In Schedule 1.01C thereto for the item '751 Ranmoor Park Road the north east side (i)' there was substituted the following:-

751. Ranmoor Park Road

The north east side:

- (i) From its junction with the north western kerb line of Fulwood Road for a distance of 5 metres in a north westerly direction.
- d) In Schedule 22.01 thereto for item 54 Main Road (i) there was substituted the following item:-

54. Main Road

- (i) Between its junctions with Staniforth Road to a point 71 metres south east of its junction with the south eastern kerb line of Prince of Wales Road.
- e) In Schedule 1.01H thereto there was deleted the item '1531 Riverdale Road' was deleted.
- f) In Schedule 2.03C thereto there was deleted the item '167 Ranmoor Park Road' and '168 Ranmoor Road'.

- (ii) From a point 88 metres south east of the projected south western kerb line of Tapton Park Road for a distance of 9 metres in a south easterly direction.
- (iii) From a point 115 metres south east of the projected south western kerb line of Tapton Park Road for a distance of 45 metres in a southerly and south easterly direction.
- (iv) From a point 21 metres north west of the north western kerb line of Fulwood Road for a distance of 5 metres in a north westerly direction.

The north west side:

(i) From its junction with its north eastern kerb line for a distance of 10 metres in a generally south westerly direction.

The west side:

(i) From a point 9 metres south of the projected south western kerb line of Tapton Park Road for a distance of 21 metres in a southerly direction.

- (iii) From a point 109 metres south of the south eastern kerb line of Fulwood Road for a distance of 12 metres in a southerly direction.
- (iv) From a point 159 metres south east of the south eastern kerb line of Fulwood Road for a distance of 9 metres in a south easterly direction.

The south west side:

- (i) From a point 15 metres north west of the north western kerb line of Graham Road to a its junction with the south eastern kerb line of Graham Road.
- (ii) From a point 11 metres north west of the north western kerb line of Riverdale Avenue to a point 5 metres south east of the south eastern kerb line of Riverdale Avenue.
