THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (HIGH STREET AND CORONATION STREET, HIGHLEY) (AMENDMENT) ORDER 2024

Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Part IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 10 February 2024 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (High Street and Coronation Street, Highley) (Amendment) Order 2024.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
i. The following sides of roads in Highley are deleted from the Schedule for No Waiting At Any Time:

Coronation Street
(North-west side)
Coronation Street
(South-east side)
High Street
(south-west side)

High Street
(north-east side)

From its junction with High Street for 17.7 metres.

From its junction with High Street for 17.8 metres.

1) Between a point 34.3 metres north of its junction with Silverdale Terrace and a point 4 metres north of its junction with Barke Street
2) Between points 7.8 and 16 metres south of its junction with Barke Street
3) From a point 55.8 metres south of its junction with Barke Street to its junction with Church Lane.
4) Between a point 53.3 metres north of its junction with Coronation Street to a point 5.9 metres south of its junction with Orchard Street
5) Between points 10.8 metres north and 142.0 metres south of its junction with Barke Street
ii. The following sides of roads in Highley are added to the Schedule for No Waiting At Any Time:

Coronation Street
(North-west side)
Coronation Street
(South-east side)

From its junction with High Street for 38 metres in a north easterly direction.

From its junction with High Street for 21 metres in a north easterly direction.
