

**THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2009 (SANDPITS ROAD, LUDLOW)
(AMENDMENT) ORDER 2022**

Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Part IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 11 February 2022 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Sandpits Road, Ludlow) (Amendment) Order 2022.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
 - i. The following sides of road in Ludlow are deleted from ParkMap Schedule 1.01 (No Waiting At Any Time):

Sandpits Road (south-west side)	From a point 2m past the property boundary of 2 Sandpits Road with 10 Orchard Gardens, to the building line of the property known as Thornwell
Sandpits Road (north-west side)	From a point opposite the boundary of numbers 5 and 7 Sandpits Road, to a point 10m south-east of its junction with White Friars.
 - ii. The following sides of road in Ludlow are added to ParkMap Schedule 1.01 (No Waiting At Any Time):

Sandpits Road (south-west side)	From a point 2m past the property boundary of 2 Sandpits Road with 10 Orchard Gardens, to a point 19m south-east of the north western property boundary of Thornwell.
Sandpits Road (north-west side)	From a point opposite the boundary of numbers 5 and 7 Sandpits Road, to a point 19m south east of the north western property boundary of Thornwell
 - iii. The following sides of road in Ludlow are added to the ParkMap Schedule for the Prohibition of Stopping on School Keep Clear Markings Mon-Fri 8am - 5pm:

Sandpits Road (both sides)	From a point 19m south east of the north-western property boundary of Thornwell easterly for a distance of 25.56m.

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation

made or having effect as if made under the Act or by or under any other enactment.
