

**THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2009 (VARIOUS STREETS, MAES-Y-CLAWDD)
(AMENDMENT) ORDER 2022**

Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Part IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 10 February 2022 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Streets, Maes-y-Clawdd) (Amendment) Order 2022.
2. The following sides of roads in Maes-y-Clawdd and Radfords Field are hereby added to ParkMap Schedule 1.01 (No Waiting At Any Time) of The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009:

Maes-Y-Clawdd (both sides)	From its junction with the B4579 Shrewsbury Road to its junction with Maesbury Road
Access road leading to Maes-Y-Clawdd Enterprise Centre (both sides)	From its junction with Maes-Y-Clawdd for a distance of 29 metres in a southbound direction
Radfords Field (north side)	From its junction with Maesbury Road for a distance of 130 metres in a south westerly then northerly direction
Radfords Field (south side)	From its junction with Maesbury Road for a distance of 109 metres in a south westerly then southerly direction
Radfords Field North cul-de-sac	From the north east corner of the cul-de-sac for a distance of 21 metres in a southerly then easterly direction
Radfords Field South cul-de-sac	From a point 4 metres north west of the south west corner of the cul-de-sac for a distance of 61 metres in a north westerly direction

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
