## THE SHROPSHIRE COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (OAK STREET, OSWESTRY) (AMENDMENT) ORDER 2023

Shropshire Council, in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49, and Part IV of Schedule 9, and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- This order shall come into operation on 21 September and may be cited as The Shropshire Council (Prohibition And Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Oak Street, Oswestry) (Amendment) Order 2023.
- The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
  - The following side of road in Oswestry is deleted from the ParkMap Schedule for No Waiting Mon-Sat 8am-6pm:

Oak Street From a point 16.0 metres north-west of the junction (south-west side) with York Street to a point 1.7 metres north-west of its

junction with Castle Street

ii. The following sides of road in Oswestry are added to the ParkMap Schedule for No Waiting Mon-Sat 8am-6pm:

Oak Street (south-west side)

(south-west side)

From a point 16.0 metres north-west of the junction with York Street to a point in line with the property boundary of 'Meatman' 94A Willow Street and 'Friends Meeting House' Oak Street.

From a point in line with the property boundary of Nos 2 Oak Cottages, Oak Street and 'Meatman' 94A Willow Street to a point 1.7 metres north-west of its junction with Castle Street.

iii. The following side of road in Oswestry is added to the ParkMap Schedule for Loading Only:

Oak Street From a point in line with the property boundary of

'Meatman' 94A Willow Street and 'Friends Meeting House' Oak Street to a point in line with of Nos 2 Oak Cottages, Oak Street and 'Meatman' 94A Willow Street.

 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
