

THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2009 (VARIOUS ROADS, PREES HEATH)
(AMENDMENT) ORDER 2023

Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Part IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 13 July 2023 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Roads, Prees Heath) (Amendment) Order 2023.

2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:

i. The following sides of roads in Prees Heath are deleted from the Schedule for No Waiting at any time:

Access road adjacent to Prees Heath Island and Lorry Park linking the A49 with Tilstock Lane (east side)

From its junction with the A49 at its southern end for a distance of 88 metres in a northerly direction

Access road adjacent to Prees Heath Island and Lorry Park linking the A49 with Tilstock Lane (west side)

From its junction with the A49 at its southern end for a distance of 100 metres in a northerly direction

ii. The following sides of roads in Prees Heath are added to the Schedule for No Waiting at any time. No loading at any time:

Access road adjacent to Prees Heath Island and Lorry Park linking the A49 with Tilstock Lane (west side)

From its junction with A49 at its southern end for a distance of 207 metres in a northerly direction to its junction with Tilstock Lane.

Access road adjacent to Prees Heath Island and Lorry Park linking the A49 with Tilstock Lane (east side)

From a point 136.6 metres south of its junction with Tilstock Lane to its junction with the A41 Wolverhampton to Whitchurch Road

Access road adjacent to Prees Heath Island and Lorry Park linking the A49 with Tilstock Lane (east side)

From its junction with Tilstock Lane to a point 45.0 metres south of that junction

Access road adjacent to Prees Heath Island and Lorry Park linking the A49 with Tilstock Lane (east side)	From a point 57 metres south of its junction with Tilstock Lane for a distance 2.5 metres in a southerly direction
Access road adjacent to Prees Heath Island and Lorry Park linking the A49 with Tilstock Lane (east side)	From a point 83.5 metres south of its junction with Tilstock Lane for a distance 2.5 metres in a southerly direction
Access road adjacent to Prees Heath Island and Lorry Park linking the A49 with Tilstock Lane (east side)	From a point 112.5 metres south of its junction with Tilstock Lane for a distance 5 metres in a southerly direction
Access road adjacent to Prees Heath Island (west side)	From its junction with the A49 at its southern end for a distance of 100 metres in a northerly direction
Access road adjacent to Prees Heath Island (east side)	From its junction with the A49 at its southern end for a distance of 88 metres in a northerly direction

iii. The following side of road in Prees Heath is added to the Schedule for Motorcycle Bays:

Access road adjacent to Prees Heath Island and Lorry Park linking the A49 with Tilstock Lane (east side)	From a point 86 metres south of its junction with Tilstock Lane for a distance 29 metres in a southerly direction

iv. The following side of road in Prees Heath is added to the Schedule for Disabled Parking Bays:

Access road adjacent to Prees Heath Island and Lorry Park linking the A49 with Tilstock Lane (east side)	From a point 59.5 metres south of its junction with Tilstock Lane for a distance 12 metres in a southerly direction

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
