

**THE SHROPSHIRE COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)  
(CONSOLIDATION) ORDER 2009 (ABBEY FOREGATE, SHREWSBURY)  
(AMENDMENT) ORDER 2019**

Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49, and Part IV of Schedule 9, and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 24 May 2019 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Abbey Foregate, Shrewsbury) (Amendment) Order 2019.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:

- i. The following sides of roads are deleted from Schedule 1.01 (No Waiting At Any Time):

**Abbey Foregate (North-west side)**

Between its junction with the English Bridge and its junction with The Narrows (that section of road adjacent to the Wakeman School).

**Abbey Foregate (North-east side)**

Between a point 14 metres north-east of its junction with The Narrows and a point 19 metres south-east of its junction with Monkmoor Road.

**Abbey Foregate Loop Road (North-west side)**

Between its western most junction with Abbey Foregate to a point 44m South-west of its junction with Railway Lane.

From a point 33m south-west of its junction with Railway Lane to its eastern-most junction with Abbey Foregate.

- ii. The following side of road is deleted from Schedule 1.14 (No Waiting, Monday to Saturday 8 am to 6.30 pm):

**Abbey Foregate (North-west side)**

From its junction with The Narrows to a point 14.1 metres north-east of that junction.

- iii. The following side of road is deleted from Schedule X77 (No Waiting Except Taxis 10pm-midnight and midnight-5am):

**Abbey Foregate Loop Road (north side)**

The taxi bay adjacent to the hardware shop and night club on Abbey Foregate.

- iv. The following side of road is deleted from Schedule 4.14 (Limited Waiting Mon-Sat 8am-6.30pm 40 Mins No Return 3 Hours):

**Abbey Foregate Loop Road (south-east side)**

From the north-east side of its junction with Railway Lane to a point 30.3 metres south-west of its south-west side with Railway Lane.

- v. The following sides of roads are added to Schedule 1.01 (No Waiting At Any Time):

**Abbey Foregate (north side)**

From the English Bridge to a point 19 metres south-east of its junction with Monkmoor Road.

**Abbey Foregate Loop Road (north side)**

Between its western-most junction with Abbey Foregate to its eastern-most junction with Abbey Foregate.

- vi. The following side of road is added to Schedule 3.03 (Loading only Mon-Sat 7.30am-6.30pm):

**Abbey Foregate Loop Road (south side)**

From the north-east side of its junction with Railway Lane for a distance of 23 metres in a south-easterly direction.

- vii. The following side of road is added to Schedule X142 (No Waiting Except Taxis):

**Abbey Foregate Loop Road (south side)**

From a point 23 metres south-east of the north-east side of its junction with Railway Lane for a distance of 10 metres in a south-easterly direction.

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
