## THE SHROPSHIRE COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (VARIOUS ROADS, SHREWSBURY) (AMENDMENT NO. 2) ORDER 2023

Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Part IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- This order shall come into operation on 24 November 2023 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Roads, Shrewsbury) (Amendment No. 2) Order 2023.
- 2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
  - i. The following side of road in Shrewsbury is deleted from the ParkMap Schedule for Restricted Parking Zone No waiting at any time. No loading at any time:

Barker Street	From its junction with Bellstone to a point in
(north-east side)	line with the southern side of the entrance to
	Barker Street car park.

 ii. The following sides of roads in Shrewsbury are deleted from the ParkMap Schedule for No waiting at any time. No loading Mon-Sat 8.15am-9.15am and 12.15pm-1.15pm and 4pm-6pm:

Barker Street (south west side)	Between points 71.2 metres and 80.1 metres north-west of its junction with Claremont Hill.
	From its junction with Bridge Street to a point 92.1 metres north-west of its junction with Claremont Hill.
Barker Street (north east side)	Between its junction with Bridge Street and the southern side of the entrance to Barker Street Car Park.
Bridge Street (west side)	Between its junction with Mardol Quay and Welsh Bridge and its junction with Barker Street.
Bridge Street (east side)	From its junction with Mardol Quay and Welsh Bridge to a point 24 metres south of its junction with Hills Lane.

iii. The following side of road in Shrewsbury is deleted from the ParkMap Schedule for Bus Stop No Stopping Except Buses:

Bridge Street	Between points 24 metres and 37.2 metres
(east side)	south of its junction with Hills Lane.

iv. The following sides of road in Shrewsbury are deleted from the ParkMap Schedule for Restricted Parking Zone No Waiting At Any Time/No Loading Mon-Sat 8.15am-9.15am and 4pm-6pm:

St Austin's Street	Between its junction with Claremont
(both sides)	Bank and Lower Claremont Bank and
	its junction with Bridge Street and
	Barker Street

v. The following sides of roads in Shrewsbury are added to the ParkMap Schedule for Restricted Parking Zone No Waiting at Any Time / No Loading at Any Time:

Barker Street (north east side)	From its junction with Bellstone to its junction with Bridge Street.
Barker Street (south west side)	Between a point 27 metres north-west of the northern property boundary of No 5 Barker Street to a point 2 metres north-west of the south-eastern flank wall of The Tannery
	Between a point 20 metres north west of the south-eastern flank wall of The Tannery and its junction with Bridge Street.
Bridge Street (both sides)	From its junction with Barker Street to its junction with Lower Claremont Bank and Hills Lane.
St Austin's Street (both sides)	Between its junction with Claremont Bank and Lower Claremont Bank and its junction with Bridge Street and Barker Street.

vi. The following sides of road in Shrewsbury are added to the ParkMap Schedule for No waiting at any time. No Loading Mon-Sat 8.15am-9.15am and 12.15pm-1.15pm and 4pm-6pm:

From its junction with Lower Claremont Bank
and Hills Lane to its junction with Mardol
Quay and Welsh Bridge.

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
