THE SHROPSHIRE COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (VARIOUS ROADS, SHREWSBURY) (AMENDMENT NO. 1) ORDER 2020

Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Part IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- This order shall come into operation on 17 April 2020 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Roads, Shrewsbury) (Amendment No. 1) Order 2020.
- 2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
 - i. The following sides of roads are deleted from ParkMap Schedule 1.01 (No Waiting At Any Time):

Alma Street (North-west side)	1) From its junction with Mount Street to a point 11 metres north-east of that junction
	2) Between points 47.6 metres and 67.1 metres north- east of its junction with Mount Street
Berwick Road (South side)	From a point 10 metres north-west of its junction with Gravel Hill Lane to a point in line with the property boundary of No 43 and 41 Berwick Road
Copthorne Road (North side)	Between a point 83 metres and a point 97 metres east of its junction with Hafren Road
Hemsworth Way (North side)	From its junction with Ellesmere Road in an Easterly direction to the start of the parking bay

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
