THE SHROPSHIRE COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (VARIOUS ROADS, SHREWSBURY) (AMENDMENT NO. 3) ORDER 2023

Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Part IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- This order shall come into operation on 16 December 2023 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Roads, Shrewsbury) (Amendment No. 3) Order 2023.
- 2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
 - i. The following sides of roads in Shrewsbury are deleted from ParkMap Schedule 1.01 (No Waiting At Any Time):

Preston Street (north side)

From its junction with Abbey Foregate to a point 124.4 metres west of its junction with Belvidere Avenue.

Between a point 12 metres west and a point 32 metres east of its junction with Belvidere Avenue.

Between points 21 metres west and 24 metres east of its junction with the south-west arm of Highfields.

ii. The following sides of roads in Shrewsbury are deleted from ParkMap Schedule 1.14 (No Waiting Mon-Sat 8am-6:30pm):

Preston Street

(north side)

Between points 12 metres and 124.4 metres west of its junction with Belvidere Avenue.

From a point 32 metres east of its junction with Belvidere Avenue to a point 21 metres west of its junction with the south-west arm of Highfields.

Preston Street

(south side) Between a point 44 metres west of its junction with Belvidere Avenue and a point 24 metres east of its junction with the south-west arm of Highfields. iii. The following sides of roads in Shrewsbury are added to ParkMap Schedule 1.01 (No Waiting At Any Time):

| Broughton Road (north-west side) | From its junction with Meadow Farm Drive north- eastwards for a distance of 16 metres measured from the Give Way line |

| Broughton Road (south-east side) | From its junction with Meadow Farm Drive north- eastwards for a distance of 10 metres measured from the Give Way line |
| Preston Street (north-east side) | From its junction with Abbey Foregate south- eastwards to a point 2 metres north-west of the property boundary of no. 27 and no. 29 Preston Street. |
| Preston Street (south-west side) | From a point adjacent to the party wall of no. 28 and no. 30 Preston Street south-eastwards to a point 2 metres north-west of the property boundary of no. 27 and 29 Preston Street. |

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
