THE SHROPSHIRE COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (AMENDMENT NO. 1) ORDER 2010

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- This order shall come into operation on 20 September 2010 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Amendment No.) Order
- 2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended as follows:
 - i) Article 14 (a) (i) is re-written to read:
 - "being actively engaged in **essential** building, industrial or demolition operations;"
 - ii) The following words are deleted from Article 14 (e):
 - "in respect of streets in the administrative areas of Broseley, Ludlow and Oswestry and Cliff Road and Love Lane in the administrative area of Bridgnorth and those streets specified within schedule 4 C of this Order being Shrewsbury Sutton Farm Match Day Residents Parking Zone"
 - iii) Article 14 (f) is deleted;
 - iv) Article 14 (h) is re-written to read:
 - "the vehicle **being actively engaged** in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository."
 - v) The words "In respect of the administrative areas of Oswestry and Bridgnorth" are deleted from Article 17;
 - vi) Article 28 is deleted;
 - vii) The phrase "In respect of the streets in Shrewsbury," is deleted from Article 41:
 - viii) The words "in the administrative areas of Bridgnorth, Oswestry and Shrewsbury Town Centre River Loop" are deleted from Article 66 (a);
 - ix) Article 72 is deleted;
 - x) Article 73 is deleted;
 - xi) Article 74 is deleted.

3.	The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
