

**THE SHROPSHIRE COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)  
(CONSOLIDATION) ORDER 2009 (VARIOUS ROADS, ALBRIGHTON)  
(AMENDMENT) ORDER 2010**

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 8 November 2010 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Roads, Albrighton) (Amendment) Order 2010.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended as follows:
  - a) the sides of roads specified in Schedule 1 to this Order are added to Schedule 1.01 (No Waiting At Any Time);
  - b) a new Schedule 2.17 (Restriction of Waiting – Monday to Friday, Between 8:00am-9:30am, and 2:30pm-4:00pm) is created and will comprise the sides of roads specified in Schedule 2 to this Order;
  - c) the sides of road specified in Schedule 3 to this Order are added to Schedule 1.18 (Prohibition of Stopping on School Keep Clear Markings).
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.

**SCHEDULE 1**

**Sides of roads at Albrighton in the County of Shropshire**

**Prohibition of Waiting at any time**

Albert Road (north-east side)	From its junction with Cross Road to a point 14 metres north-west of that junction
----------------------------------	---

Albert Road (south-west side)	From its junction with Cross Road to a point 10 metres north-west of that junction
Cross Road (both sides)	Between a point 15 metres north-east and a point 32 metres south-west of its junction with Albert Road

## **SCHEDULE 2**

### **Prohibition of Waiting – Monday to Friday, Between 8:00am-9:30am, and 2:30pm-4:00pm**

#### **Sides of roads at Albrighton in the County of Shropshire**

Cross Road (south-east side)	From its junction with Newhouse Lane to a point 15 metres north-east of its junction with Albert Road
Newhouse Lane (west side)	From its junction with Cross Road to a point 12 metres south of that junction

## **SCHEDULE 3**

### **Sides of road at Albrighton in the County of Shropshire**

#### **Prohibition of Stopping on School Keep Clear Markings**

Newhouse Lane (east side)	Between points 47.2 metres and 84.76 metres south of its junction with Garridge Close
	Between points 84.86 metres and 122.42 metres south of its junction with Garridge Close
	Between points 122.52 metres and 165.08 metres south of its junction with Garridge Close
