

**THE SHROPSHIRE COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)  
(CONSOLIDATION) ORDER 2009 (VARIOUS ROADS, BROSELEY)  
(AMENDMENT) ORDER 2010**

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 6 July 2010 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Roads, Broseley) (Amendment) Order 2010.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended as follows:
  - a) the deletion from Schedule 4.17 (1 Hour Limited Waiting Mon-Sat, 8:00am-6.30pm, No Return for 2 Hours) of the side of road specified in Schedule 1 to this Order;
  - b) the addition to Schedule 1.01 (No Waiting At Any Time) of the sides of roads specified in Schedule 2 to this Order;
  - c) the addition to Schedule 1.09 (No Waiting Mon-Sat, 8am–6pm) of the side of road specified in Schedule 3 to this Order;
  - d) the addition to Schedule 4.17 (1 Hour Limited Waiting Mon-Sat 8am-6.30pm, No Return for 2 Hours) of the side of road specified in Schedule 4 to this Order;
  - e) the addition to Schedule 5.01 (Disabled Badge Holders Only) of the side of road specified in Schedule 5 to this Order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
