

**THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2009 (VARIOUS ROADS, LUDLOW)
(AMENDMENT) ORDER 2010**

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 6 July 2010 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Roads, Ludlow) (Amendment) Order 2010.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended as follows:
 - a) the deletion from Schedule 1.01 (No Waiting At Any Time) of the sides of roads specified in Schedule 1 to this Order;
 - b) the deletion from Schedule 6.02 (Blue Area Permit Holders Only Mon-Sat 8am-6pm) of the sides of roads specified in Schedule 2 to this Order;
 - c) the addition to Schedule 1.01 (No Waiting At Any Time) of the sides of roads specified in Schedule 3 to this Order;
 - d) the addition to Schedule 4.21 (2 Hours Limited Waiting Monday-Saturday, 8am to 6pm, No Return for 1 Hour, Except Blue Area Permit Holders) of the side of road specified in Schedule 4 to this Order;
 - e) the addition to Schedule 6.02 (Blue Area Permit Holders Only Mon-Sat 8am-6pm) of the sides of roads specified in Schedule 5 to this Order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.

Sides of roads at Ludlow in the County of Shropshire

Lower Fee Access Road (north-west side)	From a point 15 metres east of its junction with St John's Lane for its whole length
Springfield Close (north, east & west side)	From its junction with Lower Galdeford along its eastern and northern side to a point 25 metres north of its junction with Lower Galdeford on its western side
Temeside (both sides)	From its junction with Old Street to a point 16 metres east of its junction with Weeping Cross Lane
Upper and Lower Fee Access Road	From its junction with St John's Lane for a distance of 20 metres in an easterly direction
Upper Fee Access Road (both sides)	From its junction with St John's Lane for a distance of 16 metres in an easterly direction

Lower Fee Access Road (north-west side)	From a point 15 metres east of its junction with St John's Lane for its whole length
Upper Fee Access Road (south-east side)	From a point 16 metres east of its junction with St John's Lane for its whole length
Upper and Lower Fee	From a point 20 metres east of its junction with St John's Lane for its whole length

SCHEDULE 3

No Waiting At Any Time

Sides of roads at Ludlow in the County of Shropshire

Belle Vue Terrace. (both sides)	From its junction with New Road for a distance of 7 metres in a southerly direction.
Bromfield Road (south-west side)	Between a point 6 metres north-west and a point 8 metres south-east of its junction with Burway Close.

Burway Close (south-east side)	From its junction with Bromfield Road (B4361) for a distance of 28 metres in a south-westerly direction.
Burway Close (north-west side)	From its junction with Bromfield Road (B4361) for a distance of 32 metres in a south-westerly direction.
Fishmore Road. (both sides)	From a point 12 metres north of its junction with Whitbatch Road to a point 10 metres south of that junction.
Livesey Road (north-west sides)	From its junction with Sandpits Road for a distance of 10 metres in a south-westerly direction.
Livesey Road (south-east sides)	From its junction with Sandpits Road for a distance of 5 metres in a south-westerly direction.
Livesey Road. (north-west side)	From its junction with St. Julians Avenue for a distance of 74 metres in a north-easterly direction.
Livesey Road. (south-east side)	From its junction with St. Julians Avenue for a distance of 33 metres in a north-easterly direction.
Lower Fee. (both sides)	From its junction with St. John's Lane for a distance of 7 metres in an easterly direction.
New Road (south-side)	Between a point 12 metres west and a point 8 metres east of its junction with Belle Vue Terrace.
Sandpits Road (north side)	Between a point 18 metres north-west and a point 12 metres south-east of its junction with Whitbread Road.
Sandpits Road (south side)	Between a point 12 metres north-west and a point 4 metres south-east of its junction with Whitbread Road.
Sheet Road (north-east side)	Between a point 10 metres north-west and a point 10 metres south-east of its junction with Sidney Road.
Sidney Road. (west and south sides)	From its junction with Sheet Road to its junction with Housman Crescent.
Sidney Road. (east side)	From its junction with Sheet Road for a distance of 11 metres in a northerly direction.
Springfield Close (both sides)	From its junction with Lower Galdeford along its eastern and northern side to a point 37 metres north of its junction with Lower Galdeford on its western side.
St. Julians Avenue. (south side)	From its junction with Livesey Road for a distance of 22 metres in a westerly direction
St. Julians Avenue. (north side)	From its junction with Livesey Road for a distance of 19 metres in a westerly direction

Temeside. (north side)	From its junction with Old Street to a point 79 metres east of its junction with Weeping Cross Lane.
Temeside. (south side)	From its junction with Old Street to a point 79 metres east of its junction with Weeping Cross Lane.
Upper Fee. (north side)	From its junction with St. John's Lane for a distance of 9 metres in an easterly direction.
Upper Fee. (south side)	From its junction with St. John's Lane for a distance of 13 metres in an easterly direction.
Upper/Lower Fee. (both side)	From its junction with St. John's Lane for a distance of 8 metres in an easterly direction.
Whitbatch Close. (both sides)	From its junction with Fishmore Road for a distance of 10 metres in a westerly direction.
Whitbread Road. (both sides)	From its junction with Sandpits Road for a distance of 10 metres in a northerly direction.

Upper and Lower Fee Access Road	From a point 8 metres east of its junction with St John's Lane for its whole length
