

**THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2009 (VARIOUS ROADS, LUDLOW)
(AMENDMENT NO. 2) ORDER 2010**

The Shropshire Council, in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 10 December 2010 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Roads, Ludlow) (Amendment No. 2) Order 2010.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended as follows:
 - a) the deletion from Schedule 7.03 (3 Hours Pay and Display, Mon-Sat 8am-6pm, No Return for 2 Hours Except Red Zone Permit Holders) of the side of road specified in Schedule 1 to this Order;
 - b) the addition to Schedule 1.01 (No Waiting At Any Time) of the sides of roads specified in Schedule 2 to this Order;
 - c) the addition to Schedule 7.03 (3 Hours Pay and Display, Mon-Sat 8am-6pm, No Return for 2 Hours Except Red Zone Permit Holders) of the side of road specified in Schedule 3 to this Order;
 - d) the addition to Schedule 20.01 (4 Hours Motorcycle Only Parking, Mon-Sat 8am-6pm No return within 2 hours) of the side of road specified in Schedule 4 to this Order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.

REVOKED

3 Hours Pay and Display, Mon-Sat 8am-6pm, No Return for 2 Hours Except Red Zone Permit Holders

Broad Street (west side)	Between a point 65 metres south of its junction with High Street and a point 10 metres north of its junction with Bell Lane.

SCHEDULE 2

No Waiting At Any Time

Sides of roads at Ludlow in the County of Shropshire

Sheet Road (north-east)	Between a point 11 metres east and 13 metres west of its junction with Steventon New Road.
Sheet Road (south west)	Between a point 11 metres east and 13 metres west of its junction with Steventon New Road.
Steventon New Road (north-east)	From its junction with Sheet Road for a distance of 30 metres in a south-easterly direction.
Steventon New Road (south-west)	From its junction with Sheet Road for a distance of 41 metres in a south-easterly direction.
King Street (north side)	Between its junction with the Bull Ring and its Junction with High Street.

SCHEDULE 3

3 Hours Pay and Display, Mon-Sat 8am-6pm, No Return for 2 Hours Except Red Zone Permit Holders

Side of road at Ludlow in the County of Shropshire

Broad Street (west side)	Between a point 52 metres south of its junction with High Street and a point 10 metres north of its junction with Bell Lane.

Side of road at Ludlow in the County of Shropshire

Mill Street
(west side)

Between points 40 metres and 50 metres south of its junction
