### THE SHROPSHIRE COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (SOUTH SHREWSBURY) (AMENDMENT) (PART 2) ORDER 2011

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order, in part.

- This order shall come into operation on 17 August 2011 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (South Shrewsbury) (Part 2) (Amendment) Order 2011.
- 2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended as follows:
  - a) Schedule 1.01 (No Waiting At Any Time) is hereby amended by the deletion of the side of road specified in Schedule 1 to this Order;
  - b) Schedule 1.14 (No Waiting Mon-Sat 8am-6.30pm) is hereby amended by the deletion of the sides of road specified in Schedule 2 to this Order;
  - c) Schedule 4.14 (40 Minutes Limited Waiting Mon-Sat 8am-6.30pm, No Return for 3 Hours) is hereby amended by the deletion of the side of road specified in Schedule 3 to this Order;
  - d) Schedule 1.01 (No Waiting At Any Time) is hereby amended by the addition of the sides of roads specified in Schedule 4 to this Order;
  - e) Schedule 1.14 (No Waiting Mon-Sat 8am-6.30pm) is hereby amended by the addition of the sides of road specified in Schedule 5 to this Order;
  - f) Schedule 3.09 (Loading Only Mon-Fri 8am-6pm. 1 Hour Limited Waiting on Saturdays between 8am-6pm with No Return for 1 Hour) is hereby amended by the addition of the side of road specified in Schedule 6 to this Order;
  - g) Schedule 4.22 (2 Hours Limited Waiting Mon-Sat 8am-6pm. No Return for 2 Hours) is hereby amended by the addition of the side of road specified in Schedule 7 to this Order.
- 3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
