

**THE SHROPSHIRE COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)  
(CONSOLIDATION) ORDER 2009 (TRINITY STREET, SHREWSBURY)  
(AMENDMENT) ORDER 2011**

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 17 August 2011 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Trinity Street, Shrewsbury) (Amendment) Order 2011.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended as follows:
  - a) Schedule 1.01 (No Waiting At Any Time) will be amended by the deletion of the sides of road specified in Schedule 1 to this Order;
  - b) Schedule 1.01 (No Waiting At Any Time) will be amended by the addition of the sides of road specified in Schedule 2 to this Order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.

| Trinity Street<br>(south-west side) | From its junction with Belle Vue Road to a point 28.6 metres south-east of that junction.       |
| Trinity Street<br>(both sides)      | Between a point 9 metres north-west and 9 metres south-east of its junction with Bynner Street. |

## SCHEDULE 2

### No Waiting At Any Time

#### Sides of road at Shrewsbury in the County of Shropshire

Trinity Street (north-east side)	From its junction with Belle Vue Road for a distance of 83 metres in a south-east direction.
Trinity Street (north-east side)	Between a point 9 metres north-west and 9 metres south-east of its junction with Bynner Street.
Trinity Street (south-west side)	From its junction with Belle Vue Road for a distance of 16 metres in a south-easterly direction.
Trinity Street (south-west side)	From a point 2 metres south-east of the north-western most property boundary of number 14 to a point 5 metres south-east of the south-eastern most property boundary of number 17.
Trinity Street (south-west side)	From a point 3 metres south-east of the north-western most property boundary of number 18 to a point 1 metre south-east of the south-eastern most property boundary of number 19.
Trinity Street (south-west side)	From a point 2 metres South-east of the property boundary of 28/29 to a point 1m South-east of the property boundary of No 32/33
Trinity Street (south-west side)	From its junction with Brynner Street for a distance of 9 metres in a south-easterly direction.
