## THE SHROPSHIRE COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (VARIOUS ROADS, DORRINGTON) (AMENDMENT) ORDER 2011

The Shropshire Council in exercise of its powers under Sections 1, 1(3), 2, 4, 5, 32, 35, 45, 46 and 49 and Part IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, and with the consent of the Secretary of State for the restrictions on the A49, hereby makes the following Order.

- This order shall come into operation on 16 December 2011 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Roads, Dorrington) (Amendment) Order 2011.
- 2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:

No Waiting At Any Time restrictions will apply to the north-east side of The Bank, (outside number 12) from the junction with A49 Main Road, to the building line of number 1 Bank Drive, and also on the opposite side of the road from the junction with the A49 Main Road to 2 metres past the southern rear property boundary of The Stores.

No Waiting At Any Time restrictions will apply to both sides of Bank Drive from the junction with The Bank to the start of the grass verge opposite number 1 Bank Drive.

The existing No Waiting At Any Time restriction on Station Road is to be extended by 20 metres to the start of the kerb radius leading to The Woodlands. The existing No Waiting At Any Time restriction on the opposite side of the road will remain unchanged.

No Waiting At Any Time restrictions will apply on the north side of Church Road from the A49 Main Road to the boundary of Home Farm and 2 Fern Brook, and on the south side of Church Road from the A49 Main Road to the start of the last window frame of The Coach House.

No Waiting At Any Time restrictions will apply to the A49 Main Road from the start of the kerb radius leading into Church Road to the southern-most building line of Home Farm. **Alternative description:** From a point 3 metres southeast of the north-east corner of The Old Coach House to a point 16.7 metres north-west of the north-east corner of The Old Coach House, including the junction with Church Road.

No Waiting At Any Time restrictions will also apply to the A49 Main Road from the start of the boundary wall of Dorrington Old Hall to the down pipe of number 13 Main Road. **Alternative description:** From a point 5 metres north of the south-west corner of 13 Main Road to a point 28.6 metres south of the south-west corner of 13 Main Road and including the junction with The Bank.

3.	The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other
	enactment.
