THE SHROPSHIRE COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (OSWESTRY TAXI BAYS) (AMENDMENT) ORDER 2011

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- This order shall come into operation on 8 February 2011 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Oswestry Taxi Bays) (Amendment) Order 2011.
- 2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended as follows:
 - a) the deletion from Schedule 3.01 (Loading Bay) of the side of road specified in Schedule 1 to this Order;
 - b) the deletion from Schedule 1.13 (No Waiting Mon-Sat 8am-6pm) of the side of road specified in Schedule 2 to this Order;
 - c) the addition to Schedule 1.04 (No Waiting At Any Time Except Taxis) of the sides of road specified in Schedule 3 to this Order;
 - d) the addition to Schedule 3.06 (Loading Bay Mon-Sat/Taxi Bay Mon-Sat 7pm-Midnight, Midnight-4am) of the side of road specified in Schedule 4 to this Order;
 - e) the addition to Schedule 1.01 (No Waiting At Any Time) of the side of road specified in Schedule 5 to this Order;
 - f) the addition to Schedule 1.13 (No Waiting Mon-Sat 8am-6pm) of the side of road specified in Schedule 6 to this Order.
- The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
