

**THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2009 (NEW ROAD, BRIDGNORTH)
(AMENDMENT) ORDER 2012**

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 25 May 2012 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (New Road, Bridgnorth) (Amendment) Order 2012.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:

The revocation of the No Waiting At Any Time restriction on:

West Castle Street (both sides)	From a point 194 metres south of its junction with Listley Street for a distance of 89 metres.

A No Waiting At Any Time restriction is placed on:

New Road (west side)	From the northernmost property wall of 21 West Castle Street to the southernmost property wall of 21 West Castle Street.

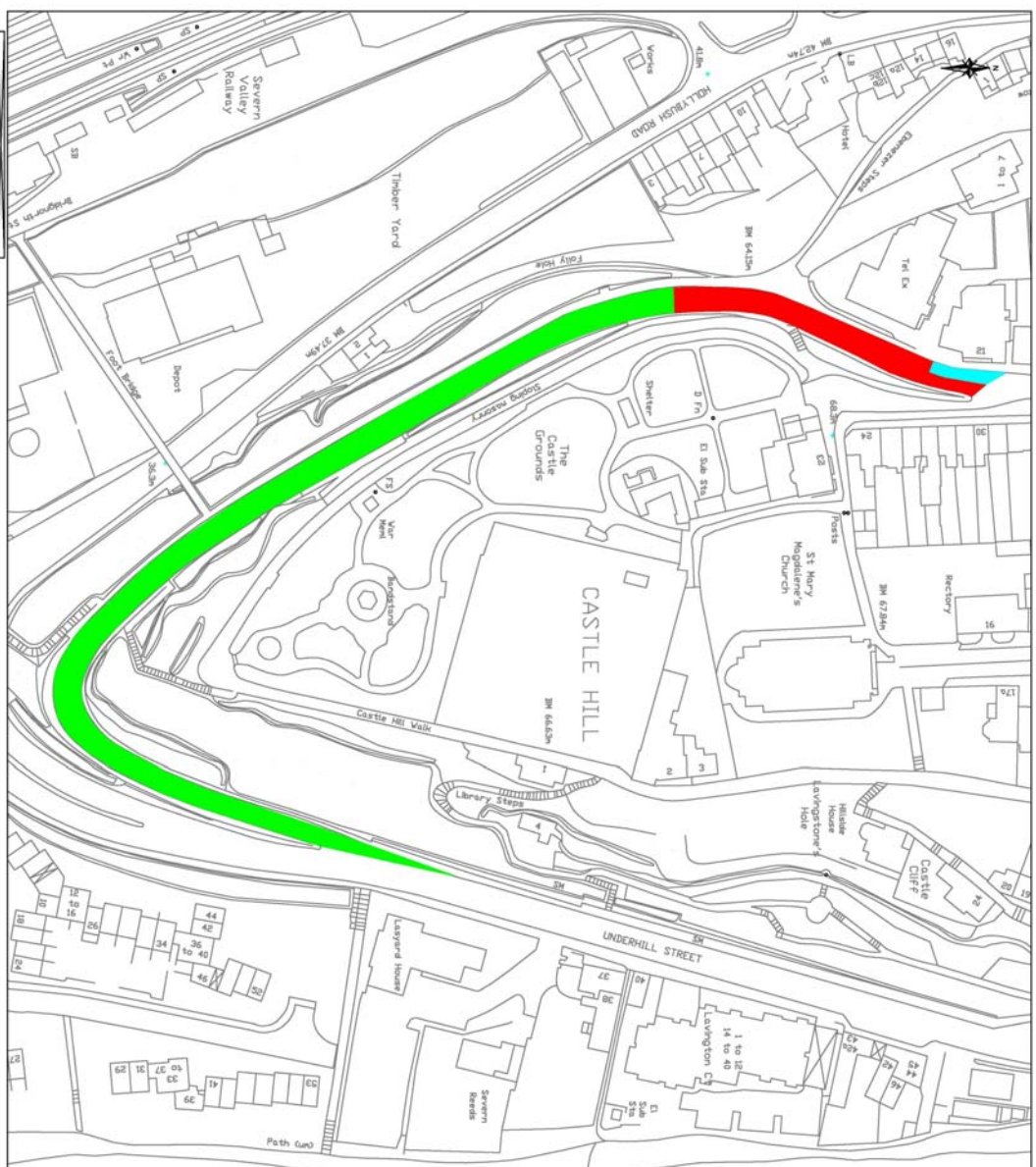
No Waiting At Any Time and No Loading At Any Time restrictions will be placed on:

New Road (west side)	From the southernmost property wall of 21 West Castle Street to its junction with Underhill Street.
-------------------------	---

New Road (east side)	From the junction with the cul-de-sac section of West Castle Street (leading to the Castle Grounds) to its junction with Underhill Street.
-------------------------	--

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
