## THE SHROPSHIRE COUNCIL

## (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (CHESTER STREET, CASTLE FOREGATE AND SMITHFIELD ROAD, SHREWSBURY) (AMENDMENT) ORDER 2012

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- This order shall come into operation on 21 September 2012 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Chester Street, Shrewsbury) (Amendment) Order 2012.
- 2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
  - a) Schedule 2.07 (Prohibition of Waiting At Any Time) with no loading/unloading Monday to Saturday, 8.15-9.1 5am, 12.15-1.1 5pm and 4.00-6.00pm will be amended by:
    - i. the deletion of the following items:

Three sections on the north-east side of Chester Street, between its junction with Smithfield Road and Cross Street.

ii. the addition of the following items:

Chester Street From its junction with Smithfield Road to a point just north of (north-east side) that junction.

From its junction with Coton Hill to a point just north of Smithfield Road.

Chester Street From its junction with Smithfield Road to a point just north of (south-west side) that junction.

Midway between its junction with Smithfield Road and Cross Street and its junction with Coton Hill.

- b) Schedule 7.04 Pay and Display (Monday to Saturday, 8.30am to 6.00pm, One Hour Limited Waiting With No Return for 2 Hours)
  - i. the deletion of the following items:

At two locations on the north-east side of Chester Street between its junction with Smithfield Road and Cross Street.

On the south-west side of Chester Street mid-way between its junction with Smithfield Road and Cross Street.

ii. the addition of the following item:

Chester Street Just north of its junction with Smithfield Road to a point (south-west side) mid-way between its junction with Cross Street.

- c) Schedule 3.03 Loading Bay Mon-Sat 7:30am-6:30pm
  - i. the addition of the following item:

Chester Street Just north of its junction with Smithfield Road. (east side)

3. The Shropshire Council (Various Streets, Shrewsbury) (Reserved Bus, Taxi and Cycle Lane) Order 2010 is hereby amended by the deletion of the following lengths of Bus, Taxi and Cycle Lane:

The two sections on the east side of Castle Foregate between its junction with Howard Street and Smithfield Road.

The east side of Castle Gates from its junction with Smithfield Road to a point just south of its junction with Meadow Place.

4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
