

**THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2009 (AMENDMENT NO. 1) ORDER 2013**

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

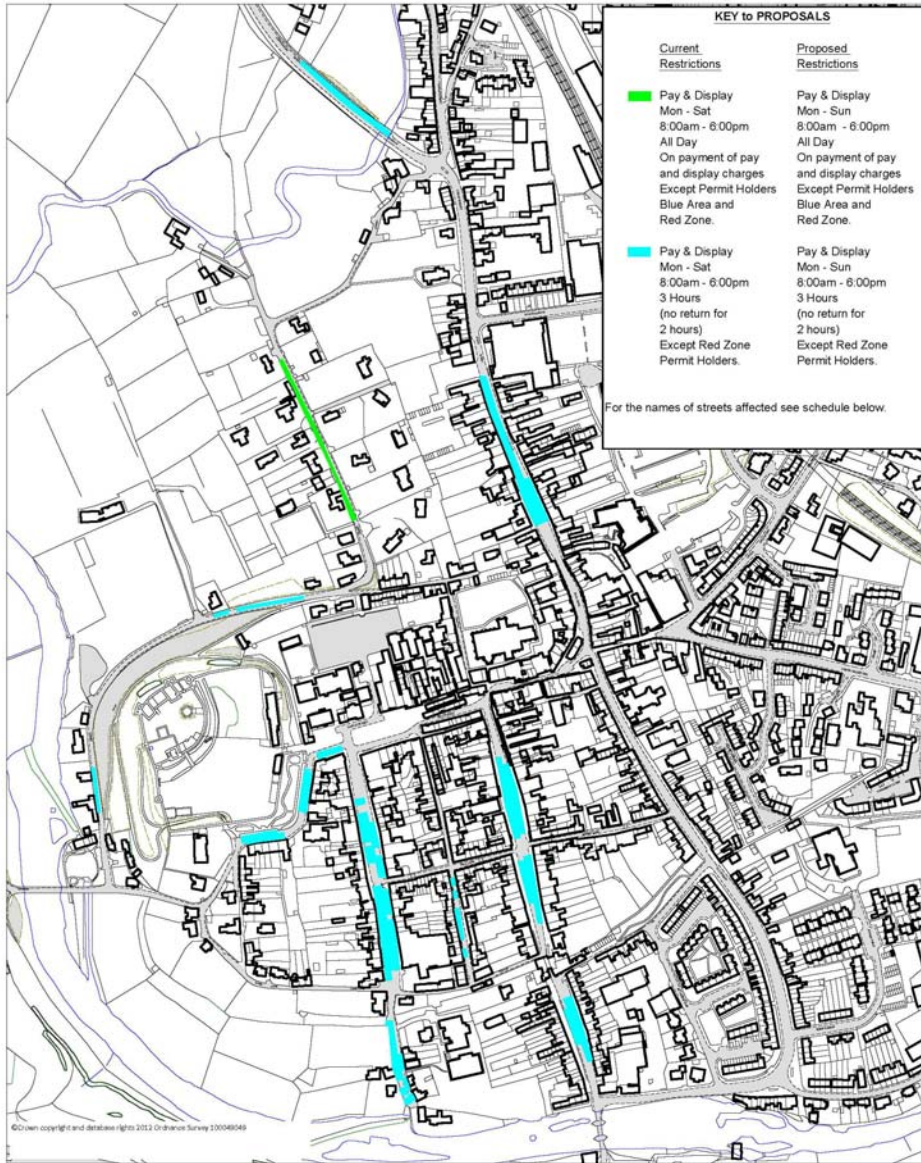
1. This order shall come into operation on 19 January 2013 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Amendment No. 1) Order 2013.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
 - i) In Schedule 2 all references to the days of operation of the Pay & Display Bays in Ludlow will be changed to read: Monday to Sunday.
 - ii) A new Schedule 7.08 (Pay & Display Mon-Sun 8am-6pm Except Permit Holders Blue Area) is hereby created. The restrictions currently in Schedule 7.01 (Pay & Display Mon-Sat 8am-6pm Except Permit Holders Blue Area) are moved into the new Schedule 7.08.
 - iii) A new Schedule 7.09 (Pay & Display Mon-Sun 8am-6pm 3 Hours waiting with No Return for 2 Hours Except Red Zone Permit Holders) is hereby created. The restrictions currently in Schedule 7.03 (Pay & Display Mon-Sat 8am-6pm 3 Hours waiting with No Return for 2 Hours Except Red Zone Permit Holders) are moved into the new Schedule 7.09.
 - iv) A new Schedule 7.10 (Pay & Display Mon-Sun 8am-6pm Except Permit Holders Blue Area and Red Zone) is hereby created. The restrictions currently in Schedule 7.05 (Pay & Display Mon-Sat 8am-6pm Except Permit Holders Blue Area and Red Zone) are moved into the new Schedule 7.10.
 - v) In Schedule 4 all references to the hours and days of operation of the Pay & Display Bays in Shrewsbury will be changed to read: 8.00am to 6:00pm, Monday to Sunday.
 - vi) A new Schedule 7.11 (Pay & Display Mon-Sun 8am-6pm, 1 hour waiting with No Return for 2 Hours) is hereby created. The restrictions in Shrewsbury that are currently in Schedule 7.04 (Pay & Display Mon-Sat 8:30am-6pm 1 Hour No Return 2 Hours) are moved into the new Schedule 7.11.
 - vii) A new Schedule 7.12 (Pay & Display Mon-Sun 8am-6pm, 2 hours waiting with No Return for 2 Hours) is hereby created. The restrictions in Shrewsbury that are currently in Schedule 7.02 (Pay & Display Mon-Sat 8:30am-6pm 2 Hours waiting with No Return for 2 Hours Except Permit Holders) are moved into the new Schedule 7.12.


- viii) A new Schedule 3.11 (Loading Bay Mon-Sun 7:30-18:30) is hereby created. The restrictions in Shrewsbury town centre that are currently in Schedule 3.03 (Loading Bay Mon-Sat 7:30-18:30) are moved into the new Schedule 3.11.
- ix) A new Schedule 3.12 (Loading Bay Mon-Sun 8:00-18:30) is hereby created. The restrictions in Shrewsbury town centre that are currently in Schedule 3.04 (Loading Bay Mon-Sat 8:00-18:30) are moved into the new Schedule 3.12.
- x) A new Schedule 2.23 (No Waiting Mon-Sun 8:00-18:00, No Loading Mon-Sat 08:15-09:15, 12.15-13.15, 16.00-18.00) is hereby created. The restrictions on Bellstone, Shrewsbury that are currently in Schedule 2.06 (No Waiting Mon-Sat 8:00-18:30, No Loading Mon-Sat 08:15-09:15, 12.15-13.15, 16.00-18.00) are moved into the new Schedule 2.23.
- xi) A new Schedule 2.24 (No Waiting Mon-Sun 8:00-18:00, No Loading Mon-Sat 08:15-09:15, 16.00-18.00) is hereby created. The restrictions on Roushill, Shrewsbury that are currently in Schedule 2.11 (No Waiting Mon-Sat 8:00-18:30, No Loading Mon-Sat 08:15-09:15, 16.00-18.00) are moved into the new Schedule 2.24.

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
