

**THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2009 (UNDERHILL STREET, BRIDGNORTH)
(AMENDMENT) ORDER 2013**

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 1 February 2013 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Underhill Street, Bridgnorth) (Amendment) Order 2013.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
 1. The following lengths of roads are hereby moved from Schedule 4.05 (Limited Waiting 8am-6pm 40 Mins No Return 1 Hour) to Schedule 4.06 (Limited Waiting 8am-6pm 40 Mins No Return 1 Hour Except Permit Holders):

Underhill Street (east side)	a) From a point 14 metres north of St Mary's Steps to a point 16 metres south of St Mary's Steps
Underhill Street (east side)	b) Between a point 105 metres south of St Mary's Steps and a point 131 metres south of St Mary's Steps
Underhill Street (east side)	c) Between a point 149 metres south of St Mary's Steps and a point 173 metres south of St Mary's Steps
Underhill Street (west side)	From a point 48 metres south of St Mary's Steps for a distance of 39 metres in a southerly direction.

2. A new Schedule 1(F) is hereby created as follows:

**Schedule 1 (F) – Underhill Street Residents parking scheme
Shared parking places – 40 Minutes Limited Waiting and Permit Holders
Monday to Sunday 8.00am to 6.00pm**

**Streets where residents (and businesses) are eligible for permits
(all properties unless otherwise indicated)**

Residents and owners of businesses in Castle Court, The Bakehouse, Bakers Mews, Stoneway House, 1-2 Underhill Street, 4-12 Underhill Street, 40 and 42-46 Underhill Street, and April Cottage (Library Steps).are eligible to apply for a permit to allow them to park in the following residents parking areas:

Underhill Street (east side)	a) From a point 14 metres north of St Mary's Steps to a point 16 metres south of St Mary's Steps
Underhill Street (east side)	b) Between a point 105 metres south of St Mary's Steps and a point 131 metres south of St Mary's Steps
Underhill Street (east side)	c) Between a point 149 metres south of St Mary's Steps and a point 173 metres south of St Mary's Steps
Underhill Street (west side)	From a point 48 metres south of St Mary's Steps for a distance of 39 metres in a southerly direction.

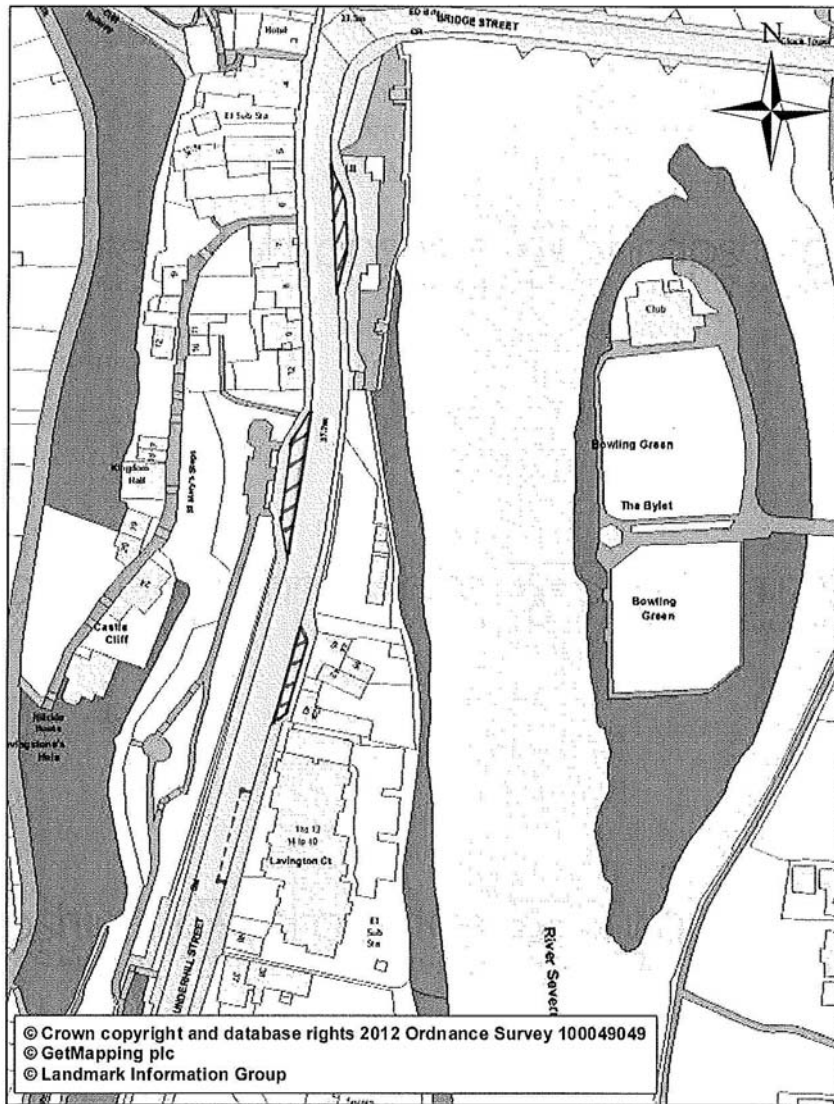
Residents permits

Residents eligible for the Underhill Street residents parking scheme may purchase 1 permit per premise valid for the Underhill Street Residents parking scheme. The level of on-street charging will be set in the manner specified in Article 8A of this Order.

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
