

**THE SHROPSHIRE COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)  
(CONSOLIDATION) ORDER 2009 (SITKA DRIVE AND ANCHORAGE AVENUE,  
SHREWSBURY) (AMENDMENT) ORDER 2013**

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 1 March 2013 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Sitka Drive and Anchorage Avenue, Shrewsbury) (Amendment) Order 2013.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:

The addition of the No Waiting At Any Time restrictions set out below:

**Sitka Drive** in its entirety with the exception of the following:

- 55 metres on the northern side adjacent to Ptarmigan Building.
- 14 metres on the northern side adjacent to Hampton by Hilton Building
- 35 metres on the southern side adjacent to Willow Building.
- 45 metres on the western side adjacent to Juniper House.
- 25 metres on the western side adjacent to Juneau House.

**Anchorage Avenue** in its entirety with the exception of 40 metres on the southern side adjacent to Mutual House.

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
