

**THE SHROPSHIRE COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)  
(CONSOLIDATION) ORDER 2009 (FROGMORE ROAD, MARKET DRAYTON)  
(AMENDMENT) ORDER 2013**

The Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 2 April 2013 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (East Castle Street, Bridgnorth) (Amendment) Order 2013.
2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
  - a) The following side of road will be deleted from Schedule 4.04 (Limited Waiting Mon-Sat 8:00am-6:00pm, 30 Mins with No Return for 1 Hour):

Frogmore Road (south-west side)	From a point 61 metres northwest of its junction with Shropshire Street for a distance of 39 metres in a north westerly direction.

  - b) The following side of road will be added to Schedule 4.04 (Limited Waiting Mon-Sat 8:00am-6:00pm, 30 Mins with No Return for 1 Hour):

Frogmore Road (west side)	between the rear access to the Festival Drayton Centre and the rear access to No. 30 Shropshire Street.

  - c) The following sides of road are deleted from Schedule 1.01 (No Waiting At Any Time):

Frogmore Road (south-west side)	From its junction with Shropshire Street for a distance of 61 metres in a north-westerly direction.  From a point 106 metres northwest of its junction with Shropshire Street to its junction with Cheshire Street.

  - d) The following sides of road are added to Schedule 1.01 (No Waiting At Any Time):

Frogmore Road (west side)	between the junction with Shropshire Street and north of the rear access to No. 30 Shropshire Street.  from south of the rear access to the Festival Drayton Centre in a north and then easterly direction to the junction with Cheshire Street.

- The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
