ORDER 2011

Shropshire Council (hereinafter called “the Council”) in exercise of its powers under Sections 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended (“the 1984 Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

PART 1
GENERAL

Commencement and Citation

1. This Order shall come into operation on 1 April 2011 and may be cited as the Shropshire Council (Off-Street Parking Places) Order 2011.

Interpretation

2. In this Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:

“Caravan” means any structure designed or adapted for human habitation which is capable of being moved from one place to another (whether by being towed or by being transported on a motor Vehicle or trailer);

“Charging Days”, means those days which are as specified at each Parking Place respectively;

“Charging Hours”, means the periods on each charging day as specified at each Parking Place respectively;

“Coach” means a motor Vehicle constructed or adapted to carry more than 15 passengers exclusive of the Driver;

“Council” means Shropshire Council or its successor authority and includes any parking services contractors or authorised agent appointed by or acting on behalf of the Council;

“Daily Charge” means the charge imposed by the Council for parking in a Parking Place on any one day and for a specified period of time as is identified in the scale of charges specified in the schedules to this Order and by notice on site;

"Disabled Persons' Badge" means a badge issued by any Local Authority in accordance with the provisions of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) Regulations 2000 or a badge having effect under those regulations as if it were a Disabled Persons' Badge);

“Driver” means the person driving the Vehicle at the time that it was Parked or driven in the Parking Place;

“Expiry Time” is the time indicated on the Ticket and is the time by which the Vehicle must leave the Parking Place;

“Heavy Goods Vehicle” means a Vehicle (other than a Passenger Vehicle) which is constructed or adapted for use for the carriage of goods or burden of any description, the overall height of which exceeds 1.85 metres and the gross vehicle weight of which exceeds 7.5 tonnes and is not drawing a trailer;

“Hotels and Guest Houses Season Ticket” means a ticket issued by the Council to a hotel, guest house, self catering or holiday let establishment to permit a Vehicle Owner, who is a guest, proprietor or employee of such an establishment, to use a Parking Place. The Hotels and Guest Houses Season Ticket will be valid for a period as determined by the Council at their discretion;

“Light Goods Vehicle” means a Vehicle constructed or adapted for use for the carriage of goods or burden of any description, the length of which does not exceed 5.5 metres, and width does not exceed 1.8 metres, and is not drawing a trailer;

“Motor Cycle” means a mechanically propelled Vehicle with fewer than 3 wheels;

“Owner” in relation to a vehicle, means the person by whom the vehicle is kept, which in the case of a vehicle registered with the Driver and Vehicle Licensing Agency or other appropriate registration authority, is the person shown to be the registered keeper, unless the contrary is proved, on the date on which the vehicle was left in the Parking Place , and in relation to a vehicle which is subject to a hiring or hire purchase agreement means the person in possession of the vehicle under that agreement;

“Park” and “Parked” refer to the stopping of a Vehicle and it remaining at rest whether or not the Driver is still in the Vehicle and a Vehicle shall be deemed to be Parked for any period in the same Parking Place or Parking Bay (as the case may be) if any part of the Parking Place or Parking Bay is below the Vehicle or the Vehicle’s load (if any) whether or not the Vehicle is moved during that period;

“Parking Bay” means an area of a Parking Place, which is provided for the leaving of a Vehicle of a class specified and indicated by markings on the surface of the Parking Place or signed or otherwise indicated by signs in the Parking Place;

"Parking Place" means an area of land provided by the Council pursuant to Section 32(1) of the 1984 Act for the purpose of parking of Vehicles and not closed (in part or in whole) by a notice erected thereon by authority of the Council;

“Passenger Vehicle” means a Vehicle (other than a Motor Cycle) constructed or adapted solely for the carriage of not more than 15 passengers (exclusive of the Driver) and their effects;

“Pay and Display Ticket” means a ticket issued by a Ticket Machine located in the Parking Place in which the Vehicle has been Parked or issued by a person nominated by the Council on payment of a charge (where required in accordance with any notice at the Parking Place) and valid for a Parking period as advertised at that Parking Place

“Penalty Charge” means a charge imposed by legislation in respect of parking contraventions that are subject to civil enforcement and has the same meaning as in the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

“Penalty Charge Notice” has the same meaning as in the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

“Permit” means a residents Permit, staff Permit, Council visitor pass or shopmobility Permit, issued subject to certain conditions determined by the Council from time to time, valid for the period specified on the Permit for use in Parking Places specified and indicated on the Permit;

“Relevant Position” means

- (a) in respect of a Vehicle displaying a valid Disabled Person’s Badge -
 - (i) in the case of a Vehicle fitted with a dashboard or fascia panel, the Disabled Person’s Badge is exhibited thereon so that Part 1 (the front of the badge), is legible from outside the Vehicle; or
 - (ii) in the case of a Vehicle not fitted with a dashboard or fascia panel, the Disabled Person’s Badge is exhibited in a conspicuous position on the Vehicle so that Part 1 of the badge is legible from outside the Vehicle;
- (b) in respect of a Vehicle displaying a Pay and Display Ticket or Parking Permit:-
 - (i) the Pay and Display Ticket or Permit is exhibited on the inside surface of the windscreen or in a clearly visible position so that it is facing forwards and can be easily seen and read from the front or side of the Vehicle; or

- (ii) in the case of a Vehicle that is not fitted with a transparent windscreen, the Pay and Display Ticket or Permit is exhibited on the front of the Vehicle facing forwards and clearly visible;

“Season Ticket” means a parking ticket, issued on payment of a fee determined from time to time by the Council, subject to certain conditions, valid for the period and in the Parking Place specified on the ticket, or otherwise specified in any conditions of use, and such term shall include the Hotels and Guest House Season Ticket;

“Ticket Machine” means an apparatus of a type and design approved by the appropriate Minister for the purpose of this Order, being apparatus designed to indicate the time by a clock and to issue Parking Tickets indicating the payment of a charge (where appropriate) and the date and, either the time of such payment, or the Expiry Time of the parking period for which a Pay and Display Ticket has been made;

“Vehicle” includes any motor car, Motor Cycle or other mechanically propelled automobile, or a wheeled vehicle normally towed or transported by a motorised vehicle including but not limited to trailers, Caravans and mobile containers.

3. Except where the context requires otherwise, any reference in this Order to a numbered Article shall be construed as a reference to the Article bearing that number in this Order.
4. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
5. Unless the context otherwise requires, words denoting the singular shall include the plural and vice versa and words denoting the persons shall include either gender, bodies corporate, unincorporated associations and partnerships.
6. The Interpretation Act 1978 shall apply for the interpretation of this Order.

7. Headings within this Order have been inserted for convenience and shall not affect the construction and interpretation of the Order.

PART 2

AUTHORISATION AND USE OF PARKING PLACES

Designation

8. Each area of land or building specified by the name in the Schedules may be used, subject to the provisions of this Order, as a place to Park Vehicles of such classes, in such positions, on such days, during such hours, for such period and on payment of such charges as are specified by notice at each Parking Place and as specified in the Schedules.

Hours of operation of Parking Places

9. Where by notice at the Parking Place, any Parking Bay within the Parking Place, is described as available on specified days during specified hours, no person shall permit any Vehicle to wait in that Parking Place on days or during hours other than those specified.

Classes of Vehicle

10. No person shall cause or permit a Vehicle to be Parked in a Parking Place unless it is a Passenger Vehicle, a Light Goods Vehicle, a Motor Cycle or a class specifically prescribed in the Schedules.

Special class of Vehicle

11. Where, by notice at a Parking Place, any Parking Bay or designated area within the Parking Place, is described as available for Vehicles of a specified class, or Vehicles of the specified class are to be Parked in a specified location, no person shall cause or permit a Vehicle to be Parked in such Parking Bay within the Parking Place,
- (i) unless it is of the specified class; or
 - (ii) in a position other than that specified; or
 - (iii) for a purpose other than provided for in this Order.

Position of Vehicle

12. If Parking Bays are marked out in a Parking Place the Driver of a Vehicle shall ensure that it is positioned wholly within a Parking Bay and shall not permit it to wait in that Parking Place unless it is in such a position.
13. If Parking Bays are not marked out in a Parking Place the Driver of a Vehicle shall ensure that the Vehicle is Parked so that it does not obstruct other Vehicles using the Parking Place, the free flow of traffic circulating within the Parking Place, or the entrances to and exits from the Parking Place.
14. Where by notice at a Parking Place, the Parking Place, or any Parking Bay within the Parking Place, is described as available for Vehicles to be Parked in a specified location, no person shall cause or permit a Vehicle to be Parked in that Parking Place or in any Parking Bay within the Parking Place,
 - (i) that is Parked beyond the Parking Bay markings; or
 - (ii) in a position other than that specified.

Disabled Persons' Parking Bays

15. No person shall cause or permit a Vehicle to be Parked in a Parking Bay marked for disabled persons unless the Vehicle displays a valid Disabled Persons' Badge in the Relevant Position and immediately before or immediately after the act of Parking the Vehicle has been or is about to be used by the person(s) in respect of whom the Disabled Persons' Badge has been issued.

Motor Cycle Parking Bays

16. No person shall cause or permit a Vehicle to Park in a Parking Bay marked for Motor Cycles unless the Vehicle is a Motor Cycle.

Vehicles with trailer or Caravan

17. For the purposes of this Order, the towing Vehicle and trailer or Caravan will be deemed to be separate Vehicles and the Owner and Driver of the towing Vehicle shall be deemed to be the Owner and Driver of each of the said Vehicles.

18. No person shall cause or permit a trailer or Caravan to be Parked in a Parking Place unless:
- (i) the registration number of the towing Vehicle is clearly displayed on the trailer,
 - (ii) all the conditions of use of the Parking Place by any Vehicle are complied with, or
 - (iii) the express written permission of the Council has been obtained.
19. No person shall cause or permit any trailer or Caravan to be Parked in a Parking Place between the hours of 8.00pm and 8.00am without the express written permission of the Council.

Maximum period of stay

20. Where specified by notice in a Parking Place, the Parking Place or any Parking Bay within the Parking Place is described as being in operation on specified days, during specified hours for a maximum period of stay, no person shall cause or permit a Vehicle to be Parked in that Parking Place or in any Parking Bay within the Parking Place on any day, during such specified hours for any period other than or longer than those specified.
21. Notwithstanding any maximum stay permitted during the hours specified in the previous Article, no person shall cause or permit any Vehicle to be Parked in any Parking Place for a period longer than 24 hours unless there is on display in the Vehicle a Season Ticket or Permit which allows for longer stays.

Period of no return

22. Where specified by notice in a Parking Place, the Parking Place is described as having a period within which a Vehicle may not return following a period of Parking, no person shall cause or permit a Vehicle to be Parked again in that Parking Place on any day, during such hours within which the Vehicle is excluded from waiting in the Parking Place.

Power to close or suspend Parking Places

23. Nothing in this Order shall prevent the Council by notice, sign or barrier displayed or erected in a Parking Place:
- (i) from closing a Parking Place or any part thereof for any period; and/or
 - (ii) from setting aside a Parking Place or any part or parts thereof for such periods of time as the Council thinks fit for use only by particular Vehicles or organisations and to specify conditions of use.
24. Any person closing a Parking Place or any part thereof shall thereupon place or cause to be placed in or adjacent to that Parking Place or that part thereof a notice or traffic sign indicating that Parking Place or that part thereof is closed or the use is suspended and that Parking by Vehicles is prohibited.

Emergency contingency plans

25. When the Council issues or places a notice on a Parking Place intimating that the Parking Place is to be closed in accordance with a contingency plan in respect of a potential emergency or flooding situation, the closure of the Parking Place shall take effect on the day and at the time specified on the notice and continue for such periods of time as the Council thinks fit.

No Parking in closed Parking Place

26. No person shall cause or permit a Vehicle to be Parked in that Parking Place or any part thereof during such periods that the Parking Place or that part thereof is closed or during such period as there is in or adjacent thereto a notice or traffic sign indicating the closure of the Parking Place placed by or on behalf of the Council.

Sale of Goods

27. No person shall in a Parking Place without the express written permission of the Council, use a Vehicle, in connection with the sale of any article, including the Vehicle itself, to any person in or near the Parking Place or in connection with the selling or offering for hire of skill or services in any other capacity.

Parked with engine running

28. No person shall in a Parking Place continue to run the engine when the Vehicle is Parked and shall not start the engine except when about to change the position of the Vehicle in or to depart from the Parking Place.

Parked causing an obstruction

29. No person shall in a Parking Place Park the Vehicle in such a manner or place where it causes an obstruction to any other users of the Parking Place.

Vehicle taxed and insured

30. No person shall cause or permit any Vehicle to be Parked in a Parking Place unless the Vehicle is licensed in accordance with the provisions of Section 1 of the Vehicles Excise and Registration Act 1994, and there is in force in relation to the use of the Vehicle by the Driver a policy of insurance as complies with Part VI of the Road Traffic Act 1988.

Offences

31. In the event of any contravention of, or non-compliance with, a provision of this Order which does not relate to a Vehicle which is stationary, the person responsible shall be guilty of an offence.
32. Nothing in this Order shall restrict or prevent the Council from exercising any of its powers under any legislation in addition to or instead of exercising its powers under this Order.

Driving within a Parking Place

33. Where in a Parking Place signs are erected or surface markings are laid for the purpose of
- (i) indicating the entrance to or exit from the Parking Place, or
 - (ii) indicating that a Vehicle using the Parking Place shall proceed in a specified direction within the Parking Place,
- any person who drives or permits to be driven any Vehicle
- (i) so that it enters the Parking Place otherwise than by an entrance or leaves the Parking Place otherwise than by an exit, so indicated, or
 - (ii) in a direction other than so specified,
- shall be guilty of an offence.
34. Any person who, without the permission of a person authorised by the Council in that behalf, drives or permits to be driven any Vehicle in a Parking Place for any purpose other than the purpose of leaving that Vehicle in the Parking Place in accordance with the provisions of this Order or for the purpose of departing from the Parking Place shall be guilty of an offence.
35. Any person who drives or permits to be driven any Vehicle in a Parking Place at a speed greater than 10 miles per hour shall be guilty of an offence.

No access to adjoining property

36. Any person who drives or permits to be driven any Vehicle in a Parking Place to gain access to an adjoining property shall be guilty of an offence:
- Provided that an exemption shall apply to any person with express written agreement with the Council for the purpose of gaining access to or from any premises adjoining the Parking Place. Any written agreement shall be subject to such terms and conditions and charges that the Council may determine.

Wilful damage

37. Any person who with intent to defraud interferes with a Ticket Machine or operates or attempts to operate it by the insertion of objects other than undamaged and unaltered coins or bank notes of legal tender and of the appropriate denomination, shall be guilty of an offence.

38. Any person, who causes damage to any parking control equipment (including Ticket Machines), signing or lighting installations within the Parking Place or to any part of the fabric of the Parking Place, shall be guilty of an offence.

Domestic purposes

39. Any person who uses any part of the Parking Place or any Vehicle, Caravan or trailer Parked in a Parking Place
- (i) for sleeping or camping or cooking, or
 - (ii) for the purpose of servicing or washing any Vehicle or part thereof other than is reasonably necessary to enable the Vehicle to depart from the Parking Place,
- shall be guilty of an offence.

Behaviour

40. Any person who wilfully sounds any horn or any other similar instrument on a Vehicle except when about to change the position of the Vehicle in or to depart from the Parking Place shall be guilty of an offence.
41. Any person who in a Parking Place shouts or otherwise makes any loud noise to the disturbance or annoyance of users of the Parking Place or residents or premises in the neighbourhood shall be guilty of an offence.
42. Any person who in a Parking Place uses any threatening, abusive or insulting language, gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned shall be guilty of an offence.

Skateboarding and other wheeled activities

43. Any person who in a Parking Place undertakes activities such as roller-skating, skate boarding, go-carting, the use of mini-motorbikes, quad bikes or any other similar vehicles to the disturbance or annoyance of users of the Parking Place or residents or occupants of premises in the neighbourhood, shall be guilty of an offence.

Other activities

44. Any person who in a Parking Place
- (i) erects or causes or permits to be erected any tent, booth, stand, building or other structure without the written consent of the Council, or
 - (ii) lights or causes to be lit any fire,
- shall be guilty of an offence.

PART 3 CHARGES FOR PARKING

Payment

45. Subject to Part 4 'Exemptions', no person shall cause or permit any Vehicle to be Parked in a Parking Place without arranging for the appropriate Daily Charge (if any) to be paid in accordance with the scale of current charges as specified by notice at the Parking Place and as specified in the Schedules.

Means of payment

46. The Daily Charges referred to in the preceding Article shall be payable in the manner as specified by notice at the Parking Place.
- For the avoidance of doubt, Daily Charges applicable at pay on exit or pay on foot Parking Places are paid immediately before the Vehicle is removed from the Parking Place.

Pay on foot Parking Places

47. At barrier controlled pay on foot Parking Places, the Driver shall obtain a ticket at the entry barrier and validate this ticket for exit by payment of the appropriate Daily Charge.

Pay and Display Parking Places

48. The Driver of a Vehicle, upon Parking the Vehicle in a Parking Bay, shall immediately ensure that a Pay and Display Ticket is obtained from a Ticket Machine situated at that Parking Place at the level of charge and for the period required in accordance with the scale of Daily Charges as specified by notice at the Parking Place and as specified in the Schedules unless a valid Season Ticket or Permit is to be used for the Vehicle.

Display of ticket

49. Once a Vehicle has been Parked within a Parking Place where a Pay and Display Ticket is required the Driver of the Vehicle shall ensure that unless a valid Season Ticket or Permit is displayed on the Vehicle:
- (i) a valid Pay and Display Ticket has been obtained to cover the entire period that the Vehicle is Parked in the Parking Place, and
 - (ii) the valid Pay and Display Ticket is displayed in the Relevant Position on the Vehicle in respect of which it was issued at all times the Vehicle is Parked.

Validity of a Pay and Display Ticket

50. A Pay and Display Ticket is not transferable from one Vehicle to another and on transfer the Pay and Display Ticket ceases to be valid.
51. A Pay and Display Ticket is valid only in the Parking Place in which it was issued. This is defined by the reference code of the Ticket Machine located in that Parking Place printed on the Pay and Display Ticket.

Expiry of Parking period

52. The expiry of the period for which the appropriate charge has been paid occurs when the time shown on the clock of the issuing Ticket Machine is later than the Expiry Time shown on the Pay and Display Ticket displayed on the vehicle.
53. A Vehicle shall not be Parked in a Parking Place after the expiry of a displayed Pay and Display Ticket.

No Pay and Display Ticket displayed

54. If at any time while a Vehicle is Parked in a Parking Place where a Pay and Display Ticket is required and no Pay and Display Ticket or valid Season Ticket or Permit is displayed on that Vehicle in the Relevant Position, and in accordance with the provisions of this Order, it shall be deemed that the Daily Charge has not been paid.
55. If at the time when a Vehicle is Parked during the Charging Hours in a Parking Place and the nearest Ticket Machine in that Parking Place is out of order, then a ticket shall be obtained from another Ticket Machine within the same Parking Place (where provided) or as directed in the Parking Place.

Season Tickets, Permits and Council visitor passes

56. Season Tickets are available from the Council at the appropriate fee as specified in the Schedules, for a Vehicle of a specific class and for a specific Parking Place subject to conditions determined by the Council.
57. The proprietor or manager of a hotel, guest house, self catering or holiday let establishment may, on application to the Council, purchase a Hotels and Guest House Season Ticket for such a charge as may be determined by the Council from time to time. The Hotels and Guest Houses Season Ticket shall be valid in such Parking Places as are specified thereon during the period in respect of which it has been issued.
58. A Hotels and Guest Houses Season Ticket shall be valid for use in a named Parking Place specified by the Council.
59. The Council may issue Permits to its members and staff to allow their Vehicles to Park in specific Parking Places subject to conditions determined by the Council.
60. The Council may issue Permits to its residents living within specified areas to allow residents Vehicles to Park in specific Parking Places subject to conditions determined by the Council.

61. A duly authorised officer of the Council may issue a Permit to members of the public enacting business with the Council, to allow Vehicles to Park in specific Parking Places subject to conditions determined by the Council.
62. A Season Ticket or Permit is only valid
- (i) if it was issued by the Council,
 - (ii) it is used in the Parking Place(s) in respect of which it was issued,
 - (iii) it is used for the Vehicle in respect of which it was issued, and
 - (iv) for use up to the date of expiry shown on the Season Ticket or Permit.
63. No person shall alter copy or duplicate the information on a Season Ticket or Permit and if an altered, copied or duplicated Season Ticket or Permit is displayed on a Vehicle it shall be deemed to be invalid.
64. The Driver shall abide by the terms stipulated by the Council for the use of the Season Ticket or Permit.

Display of Season Ticket, staff Permit or visitor pass

65. A Season Ticket or Permit shall be displayed in the Relevant Position on the Vehicle in respect of which it was issued at all times during which the Vehicle is Parked in the Parking Place.

Replacement Season Tickets / Parking Permits

66. Damaged or lost Season Tickets or Permits will be replaced on application to the Council and on payment of an administration fee in accordance with the Council policy in place at that time. The damaged or lost Season Ticket or Permit will then become immediately invalid.

Surrender and refunds

67. A Season Ticket or Permit remains the property of the Council and must be surrendered on request. In such instances any refund of fee paid will be provided in accordance with the Council policy in place at that time.

Restriction on removal

68. When a Pay and Display Ticket or Season Ticket or Permit has been exhibited on a Vehicle in the Relevant Position no person shall remove the Pay and Display Ticket or Season Ticket or Permit from the Vehicle until the Vehicle is removed from the Parking Place.

Vehicles displaying a valid Disabled Persons' Badge

69. In all pay and display Parking Places the normal charging rates will apply and a Pay and Display Ticket must be displayed to cover the entire period that the Vehicle is Parked in the Parking Place.

PART 4 EXEMPTIONS

Motor Cycles

70. No Daily Charge shall be payable in respect of a Motor Cycle Parked in a marked Motor Cycle Parking Bay.

Season Tickets and Permits

71. No Daily Charge shall be payable in respect of a Vehicle Parked displaying in a Relevant Position a Season Ticket or Permit valid for that time and that Parking Place.

Absence of Ticket Machine

72. If at the time when a Vehicle is Parked in a Parking Place during the Charging Hours there is no Ticket Machine at the Parking Place, or all the Ticket Machines at that Parking Place carry notices placed upon them by a person duly authorised by the Council indicating that the Ticket Machine is out of order, the Driver of that Vehicle shall be exempt from purchasing a Pay and Display Ticket but the Vehicle may not be Parked for longer than the maximum period of Parking in that Parking Place as specified by notice at the Parking Place.

Emergency services

73. No Daily Charge or time limit in any Parking Place shall apply to liveried Vehicles being used in pursuance of statutory powers of the Fire and Rescue, Police or Ambulance services.

PART 5

RELOCATION, REMOVAL AND DISPOSAL OF VEHICLES

Contravention of Order

74. A person authorised by the Council may, using such measures as are appropriate, remove or move or cause to be removed or moved to any place he/she thinks fit, any Vehicle Parked in a Parking Place in contravention of any conditions of this Order.

Emergencies

75. A person authorised by the Council or a police officer in uniform may, using such measures as are appropriate, remove or move or cause to be removed or moved in the case of an emergency to any place he/she thinks fit, any Vehicle Parked in a Parking Place.

Contraventions in suspended Parking Place

76. A person authorised by the Council may, using such measures as are appropriate, remove or move or cause to be removed or moved to any place he/she thinks fit, any Vehicle Parked in a Parking Place which has been closed in whole or in part by notice by the Council.

Abandoned Vehicles

77. A person authorised by the Council may, using such measures as are appropriate, remove or move or cause to be removed or moved to any place he/she thinks fit, any Vehicle Parked in a Parking Place which appears to the Council to have been abandoned.

Cost of removal and storage

78. Where a Vehicle has been left in a Parking Place in contravention of this Order or following the issue of a notice of closure of the Parking Place and has subsequently been moved or removed by the Council, the cost of movement or removal and safe keeping shall be the liability of the Owner of the Vehicle.

Safe keeping

79. Any person removing a Vehicle from a Parking Place under the provisions of this Order shall make such arrangements as may be reasonably necessary to provide for the safe keeping of the Vehicle.

Disposal of Vehicles abandoned in Parking Places

80. The Council may sell or otherwise dispose of, in accordance with appropriate legislation, a Vehicle which has been, or could at any time be, removed from a Parking Place if the Vehicle appears to have been abandoned.

PART 6 CONTRAVENTION AND PENALTY CHARGE

Contravention

81. Save for the provisions in Part 7, if a Vehicle is Parked in a Parking Place without complying with the requirements of this Order, or an offence has otherwise been committed in contravention of this Order, a contravention shall have occurred and a Penalty Charge shall be payable. A Penalty Charge Notice may then be served and/or the Vehicle may be removed from the location.

Restriction on removal of notices

82. Any notice fixed to a Vehicle in accordance with this Order shall not be removed or interfered with except by or under the authority of:
- (i) the Owner, or person in charge of the Vehicle;
 - (ii) the Council for the Parking Place in which the Vehicle in question was found.

Indications as Evidence

83. The particulars given in any Penalty Charge Notice served on a Vehicle in accordance with the provisions of this Order shall be treated as evidence in any proceedings relating to failure to pay the Penalty Charge.

PART 7

LIABILITY AND OTHER PROVISIONS

Liability

84. The Council accepts no liability for the loss or damage to Vehicles or other property left in any of the Parking Places to which this Order applies save for that arising from the negligence of the Council.

No right of way

85. No rights of way whatsoever over any Parking Place shall be deemed to have been granted by the Council by this Order.

Validity

86. If a court, the Department for Transport, the Traffic Penalty Tribunal or the Traffic Enforcement Centre declares any part of this Order to be invalid or unenforceable, such declaration shall not invalidate the remainder of the Order.

PART 8
