

**THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2009 (VARIOUS ROADS, BAYSTON HILL)
(AMENDMENT) ORDER 2014**

Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This order shall come into operation on 4 April 2014 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Roads, Bayston Hill) (Amendment) Order 2014.
2. Schedule 1.01 (No Waiting At Any Time) of The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:

The revocation of the following side of road:

Overdale Road (north-east side)	1) Between a point 13.7 metres north-west of its junction with Langford Avenue and a point 8.4 metres south-east of its junction with Berwyn Drive.

The addition of the following sides of roads:

Cornwall Drive (both sides)	From its junction with Lyth Hill Road to a point in line with the original property frontage of No 31 Lyth Hill Road.
Hollies Drive (Both sides)	From its junction with Lansdowne Road to the boundary of No 2 Hollies Drive and No 2 Lansdowne Road.
Lansdowne Road (North-east side)	From a point 3 metres south-east of the boundary (north-east side) between No 1 Sarn Cottages and No 1 Hollies Drive to a point opposite the boundary between No. 7 and No. 9 Lansdowne Road.
Lyth Hill Road (East side)	From a point adjacent to the property boundary of No.33 and No. 35 Lyth Hill Road, north to a point adjacent to the property boundary of No. 29 and No. 31 Lyth Hill Road.
Overdale Road (North-east side)	Between a point 3 metres north-west of the boundary of Nos.62 /64 and Nos.66/68 Overdale Road and a point adjacent to the boundary of Nos.54/56 and Nos.58/60 Overdale Road.

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.




