THE SHROPSHIRE COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (BEECHES LANE AND WYLE COP, SHREWSBURY) (AMENDMENT) ORDER 2014

Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- This Order shall come into effect on 8 August 2014 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Beeches Lane and Wyle Cop, Shrewsbury) (Amendment) Order 2014.
- The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
 - The following sides of roads are deleted from Schedule 2.07 (No Waiting At Any Time No Loading 8:15am-9:15am, 12.15pm 1.15pm and 4:00pm-6:00pm):

Wyle Cop From its junction with Beeches Lane to a point 49

(north side) metres east of that junction.

Wyle Cop From its junction with Beeches Lane to a point 58

(south side) metres east of that junction.

Beeches Lane From its junction with Wyle Cop to a point 30

metres west of that junction.

ii. The following sides of roads are added to Schedule 2.01 (No Waiting or Loading At Any Time):

Wyle Cop From its junction with Beeches Lane to a point 49

(north side) metres east of that junction.

Wyle Cop From its junction with Beeches Lane to a point 21

(south side) metres east of that junction.

Beeches Lane From its junction with Wyle Cop to a point 30

(both sides) metres west of that junction.

iii. The following side of road is added to Schedule X14 (Loading Bay – 7:30am-6:30pm):

Wyle Cop From a point 21 metres east of its junction with Beeches

(south side) Lane to a point 24 metres east of that point.

 The prohibitions and restrictions imposed by this order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
