THE SHROPSHIRE COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (VARIOUS ROADS, WEM) (AMENDMENT) ORDER 2015

Shropshire Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 45, 46 and 49 and Parts IV of Schedule 9 and having regard to Section 122 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- 1. This order shall come into operation on 6 February 2015 and may be cited as The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 (Various Roads, Wem) (Amendment) Order 2015.
- 2. The Shropshire Council (Prohibition and Restriction of Waiting and Parking Places) (Consolidation) Order 2009 is hereby amended to incorporate the following changes:
 - i. The revocation of the following side of road from Schedule 1.01 (No Waiting At Any Time):

Aston Street From its junction with Aston Road to a point 279.9 (south side) metres east of its junction with Talbot Street

ii. The revocation of the following side of road from Schedule 1.03 (Restriction of Waiting between Monday – Saturday, 8.30am and 6.00pm):

Aston Street Between points 18.5 metres and 148.7 metres east (south side) of its junction with Talbot Street

iii. The revocation of the following side of road from Schedule 4.16 (Limited waiting (1 hour) Parking Places between Monday – Saturday, 8.30am and 6.00pm. No return within 1 hour):

Aston Street Between points 148.7 metres and 261.1 metres east (south side) of its junction with Talbot Street

iv. The revocation of the following side of road from Schedule 10.02 (Bus Stop – No stopping except buses):

Aston Street Between points 261.1 metres and 279.9 metres (south side) east of its junction with Talbot Street

v. The addition of the following sides of roads to Schedule 1.01 (No Waiting At Any Time):

Aston Street From its junction with Aston Road to a point 244.5 (south side) metres east of its junction with the access road leading to the supermarket car park adjacent to

Leek Street
