THE BOROUGH OF SLOUGH (WAITING RESTRICTIONS AND RESIDENTS' PARKING ORDER 2010) (AMENDMENT NO. 29) ORDER 2013 (ORDER 59 OF 2013) ('the Order')

- 1. SLOUGH BOROUGH COUNCIL makes this Order in exercise of its powers under section 9 of the Road Traffic Regulation Act 1984.
- 2. The Order shall come into force before the expiration of the period of seven days beginning with the day on which a notice of making in relation to the order is published.
- 3. The Order shall not continue in force for longer than 18 months.
- 4. The effect of this Order is to amend the Borough of Slough Waiting Restrictions and Residents' Parking Order 2010 ('the 2010 Order') to create double yellow lines and to create parking bays allowing parking on pavements in certain circumstances. This Order will be effected alongside the Borough of Slough (PROHIBITION OF FOOTWAY PARKING) ORDER 2013 (Order 59 of 2013) with the purpose of controlling pavement parking. Pavement parking has been a concern and occurs in many areas of the Borough causing obstruction for pedestrians, environmental deterioration and damage to the pavement as a result.
- 5. This order supersedes and revokes in its entirety 'The Borough of Slough (Waiting Restrictions and Residents' Parking Order 2010) (Amendment No. 25) Order 2013 (Order 26 of 2013)
- 6. While the Order is in operation:
 - (a) The items relating to Stoke Road are deleted from Schedule 1.02 of the 2010 Order.
