

**Sections 1 and 9 of the Road Traffic Regulation Act 1984 and regulation 23 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996.**


**THE BOROUGH OF SLOUGH (AMENDMENT NO.32) (WAITING RESTRICTIONS AND RESIDENTS' PARKING ORDER 2010) ORDER 2015 (ORDER 9 of 2015) ("Order")**

1. SLOUGH BOROUGH COUNCIL makes this Order in exercise of its powers under sections 1 and 9 of the Road Traffic Regulation Act 1984, regulation 23 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and any other enabling powers.
2. The Order shall come into operation on the date on which notice that it has been made is first published.
3. The sole effect of this Order is to reproduce and continue in force indefinitely the provisions of a previous experimental order made under section 9 of the Road Traffic Regulation Act 1984. The previous experimental order is named 'The Borough of Slough (Amendment No.23) (Experimental) (Waiting Restrictions and Residents' Parking Order 2010) Order 2013' ("the Experimental Order").
4. The Experimental Order, which is continued indefinitely whilst this Order is in force, introduced a combination of limited-waiting parking places from 8am – 6pm Monday – Saturday on Wexham Street, No Waiting Except Taxis from 7pm – 3am on all days on High Street West, Slough and No Stopping Except Taxis on High Street, Slough, Queensmere Road and Church Street, Slough. The items relating to Farnham Road in the Experimental Order will not be made permanent under this Order, with the effect that the taxi rank put in place by the Experimental Order will be removed and that part of Farnham Road will revert back to limited waiting parking as regulated under the Borough of Slough Waiting Restrictions and Residents' Parking Order 2010.
5. The effect of this Order will be to make permanent the following provisions of the Experimental Order being the following amendments to the Waiting Restrictions and Residents' Parking Order 2010 ("the 2010 Order"):
  - a. Schedule 4.10 of the 2010 Order is amended by the addition of the wording in Schedule A to this Order;
  - b. The items relating to High Street, Slough in Schedule 9.02 of the 2010 Order are deleted and replaced with the items contained in Schedule B of this Order;
  - c. The items relating to High Street (west), Slough, High Street, Slough, The Grove, Church Street, Slough, Wellington Street and Queensmere Road are deleted from Schedule 11.01 of the 2010 Order;
  - d. Schedule 11.01 of the 2010 Order is amended by the addition of the wording in Schedule C to this Order;

- e. Schedule 11.02 of the 2010 Order is amended by the addition of the wording in Schedule D to this Order;
- f. Article 51 of the 2010 Order is deleted and replaced with Schedule E to this Order.
