THE BOROUGH OF SLOUGH WAITING RESTRICTION AND RESIDENTS' PARKING (CONSOLIDATION) ORDER 2010 (NOTICE OF VARIATION – CASHLESS PARKING ON STREET) ORDER 2015 (ORDER 4 OF 2015) ('Order')

1. SLOUGH BOROUGH COUNCIL makes this Order in exercise of its powers under sections 45 and 46 of the Road Traffic Regulation Act 1984 and any other enabling powers.
2. This Order shall come into operation on the date on which a notice that it has been made is first published.
3. While this Order is in operation, the Off Street Parking Places (Special Parking Area) (Consolidation) Order 2010 ('the 2010 Order') shall be varied as follows:
 - a. Part I of the 2010 Order is amended by the addition of the following wording –
“approved method of payment” means payment by:
 - a) cash using a combination of coins of the following denominations: 10 pence, 20 pence, 50 pence, 1 pound, or 2 pounds and where more than one coin is required for payment of that parking charge the coins shall be inserted one following another in a ticket machine relating to that parking place; or
 - b) debit or credit card using a mechanical device; or
 - c) debit or credit card facilitated by on site or remote verification by mobile phone text, phone call or application; or
 - d) or such other method of payment as the Council may from time to time authorise.
 - b. Article 36(a) of Part XIII of the 2010 Order is deleted in its entirety and replaced with the following wording –
“Any person may cause or permit a vehicle to wait in any of the parking places as parking places specified in Column 5 of Schedule 9.02 of this Order for that purpose PROVIDED THAT for the duration of that vehicle's permitted parking:
 - (a) that vehicle displays a valid parking ticket issued under the following provisions of this Order; OR
 - (b) the appropriate parking charge has been paid for the duration of that vehicle's permitted parking by an approved method of payment at the commencement of a period of permitted waiting.
 - c. Article 36(b) of Part XIII of the 2010 Order is deleted in its entirety and replaced with the following wording –
“No person shall cause or permit a vehicle to wait in any of the parking places designated in Schedule 9.02 to this Order where the duration of

that vehicle's permitted parking purchased by obtaining a parking ticket or through an approved method of payment has expired."

- d. Article 40(a) of Part XIII of the 2010 Order is deleted in its entirety and replaced with the following wording –

"A parking charge shall become payable upon the leaving of a vehicle in a parking place referred to in Article 33 above and where a charge is specified. A parking charge shall be payable by an approved method of payment."

- e. Article 40(b) of Part XIII of the 2010 Order is deleted in its entirety and replaced with the following wording –

"If a parking ticket is purchased, the parking ticket shall be displayed in accordance with Article 38 above."

- f. Article 40(c) of Part XIII of the 2010 Order is deleted in its entirety and replaced with the following wording –

"Where a vehicle is left in a parking place designated by Schedule 9.02 of this Order as a pay and display parking place during the controlled hours and beyond the expiry of the time indicated on the parking ticket displayed in the vehicle or the time purchased through an approved method of payment, a Penalty Charge Notice shall be payable and may be affixed to the vehicle or given to a person appearing to be in charge of that vehicle."
