
BOROUGH OF SLOUGH (WAITING RESTRICTIONS AND RESIDENTS PARKING) ORDER 2006. (AMENDMENT No. 2) 2007

The Council of the Borough of Slough, in exercise of the powers conferred on it under Sections 1(1) and (2), 2(1) and (2), 4 and 124 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and in accordance with Parts I to III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. This Order shall come into operation on the 29th January 2007 and may be `cited as "The Borough of Slough (Waiting Restrictions and Residents' Parking) Order 2006.
- 2. The Borough of Slough Waiting Restrictions and Residents' Parking Order 2005 be amended by the addition of a new Article 35 as follows:-
 - "No person shall except upon the direction or with the permission of a police officer in uniform, traffic warden or parking attendant cause or permit any vehicle other than a taxi to wait at any time on the lengths of road or sides of road specified in Schedule 1.03 hereto"
- 3. The Borough of Slough Waiting Restrictions and Residents' Parking Order shall have effect as though:-
 - (a) Schedule 2.01 thereto is amended by the suspension of the provisions detailed in Schedule "A" below
 - (b) Schedule 2.02 thereto is amended by the suspension of the provisions detailed in Schedule "B" below
 - (c) Schedule 8.03 thereto is amended by the deletion of the provisions detailed in Schedule "C" below
 - (d) Schedule 9.01 thereto is amended by the suspension of the provisions detailed in Schedule "D" below
 - (e) Schedule 1.01 thereto is amended by the addition of the provisions detailed in Schedule "E" below
 - (f) Schedule 2.01 thereto is further amended by the addition of the provisions detailed in Schedule "F" below
 - (g) Schedule 5.10 is amended by the addition of the provisions detailed in Schedule "G" below.
 - (h) Schedule 8.03 thereto is further amended by the addition of the provisions detailed in Schedule "H" below



- (i) A new Schedule 11.02 is added as detailed in Schedule "I" below
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

STATEMENT OF REASONS

Re-development of the Tesco Superstore has resulted in alterations being made to the carriageways of Wellington Street and Brunel Way which, in turn have required traffic movements to be regulated within these roads.

In addition to the regulation of traffic movements, improved facilities have provided for pedestrians, cyclists, local buses and taxis, all of which lead to improved road safety levels in both roads for all road users.

Both sides:

Between the east side of its roundabout junction with William Street and the west side of its roundabout junction with the

(north/south arm) Both sides of the taxi feeder rank located on the east side of

Brunel Way between a point approximately 14 metres north

of its junction with Wellington Street northwards for a

distance of approximately 93 metres

High Street

North side:

From a point approximately 3 metres west of the common boundary of Nos. 145/147 High Street westwards for a

distance of approximately 30 metres

The Grove

West side:

The lay-by situated on the west side from a point

approximately 12 metres north of the northern kerb line of Bishops Road northwards for a distance of approximately 11

Metres

Queensmere Service Road

South side:

The lay-by to the rear of The Observatory
