THE BOROUGH OF SLOUGH WAITING RESTRICTIONS AND RESIDENTS' PARKING ORDER 2006 (AMENDMENT No.4) 2007

The Council of the Borough of Slough on the 31st May 2007 made The Borough of Slough Waiting Restrictions and Residents' Parking Order 2006 (Amendment No.4) 2007 under the Road Traffic Regulation Act 1984 the effect of which prohibits waiting on lengths of Aldin Avenue South, Buttermere Avenue at its junctions with Windermere Way and Derwent Drive, Banbury Avenue, Oxford Avenue and in the service road fronting Nos.142 to 164 Farnham Road. It also introduces permit parking for residents on the adopted length of Aldin Avenue South.

The Order also addresses minor anomalies in The Borough of Slough Waiting Restrictions and Residents' Parking Order 2006 which have become apparent since its implementation in December 2006.

The Order comes into effect on 2nd July 2007. A copy of the Order can be inspected at the Town Hall, Bath Road, Slough SL1 3UQ and My Council, Landmark Place, Windsor Road, Slough SL1 1HL during normal office hours and at The Central Library, High Street, Slough SL1 1EA during normal opening hours.

Anyone wishing to question the validity of the Order or of any of its provisions on the grounds that they are not within the powers of the Act, or that any requirement of the Act or Regulations under it have no been complied with, may do so within six weeks from 15th June 2007 by applying to the High Court.

THE BOROUGH OF SLOUGH WAITING RESTRICTIONS AND RESIDENTS' PARKING ORDER 2006(AMENDMENT No.4)2007

The Council of the Borough of Slough, in exercise of the powers conferred on it under Sections 1(1) and (2), 2(1) and (2), 4, 32 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act') and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. This Order shall come into effect on the 2nd July 2007 and may be cited as "The Borough of Slough Waiting Restrictions and Residents' Parking Order 2006 (Amendment No.4) 2007.
- 2. The Borough of Slough Waiting Restrictions and Residents' Parking Order 2006 shall have effect as though:
- (a) Schedules 3.01 were amended by the deletion of all references to Aldin Avenue South
- (b) Schedule 3.02 were amended in respect of Weston Road West side by the deletion of Item (i) and East side by the deletion of Items (ii) and (iii).
- (c) Schedule 3.05 were amended in respect of Banbury Avenue by the deletion of all references relating to the South and East side.
- (d) Schedule 4.01 were amended by the deletion of all references to Aldin Avenue South
- (e) Schedule 2.01 were amended by the addition of the wording as set out in Schedule 'A' hereto.
- (f) Schedule 3.02 were amended by the addition of the wording as set out in Schedule 'B' hereto.
- (g) Schedule 8.01 were amended by the addition of the wording as set out in Schedule 'C' hereto.
- (h) Schedule 8.02 were amended by the addition of the wording as set out in Schedule 'D' hereto.
- (i) Article 2(2) were amended by the deletion of all references to 'Schedule 11.01' and the insertion of the words 'Schedules 11.01 and 11.02' in their place.
- (j) Article 43 were amended by the deletion of the last sub-article heading '(c)' and the insertion of '(e)' in its place.
- (k) The reference to 'PART X1V' is amended to read 'PART XIV'.
- (j) Schedule 2.01 were amended by the deletion of the wording as set out in Schedule 'E' hereto.
- (m) Schedule 3.05 were amended in respect of Buckingham Avenue South side by the deletion of the words 'Henley Avenue' and the insertion of 'Henley Road' in their place.
