THE BOROUGH OF SLOUGH WAITING RESTRICTIONS AND RESIDENTS' PARKING ORDER 2006 (AMENDMENT No.7) 2007

The Council of the Borough of Slough on the 19th April 2007 made The Borough of Slough Waiting Restrictions and Residents' Parking Order 2006 (Amendment No.7) 2007 under the Road Traffic Regulation Act 1984 the effect of which varied existing waiting restrictions in Victoria Road and Eastbridge so as to create more unrestricted carriageway space for on-street parking and prohibited waiting along the north side of the western arm of Oxford Avenue between 7am and 7pm on Monday to Friday to maintain freedom of movement for vehicular traffic throughout the working day. Waiting is also prohibited at all times along the east side of the service road fronting Nos.15 to 31 High Street, Chalvey to address obstructive parking by non-residents.

This Order comes into operation on the 14th May 2007. A copy of the Order can be inspected at the Town Hall, Bath Road, Slough, SL1 3UQ and My Council, Landmark Place, High Street, Slough, SL1 1JL during normal office hours and at The Central Library, High Street, Slough, SL1 1EA during normal opening hours.

Anyone wishing to question the validity of the Order or of any of its provisions on the grounds that they are not within the powers of the Act, or that any requirement of the Act or Regulations under it have not been complied with, may do so within six weeks from 27th April 2007 by applying to the High Court.

- Schedule 3.05 were amended by the addition of the wording as set out in Schedule 'C' hereto;
- Schedule 3.08 were amended by the addition of the wording as set out in Schedule 'D' hereto;
- The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
