THE BOROUGH OF SLOUGH
WAITING RESTRICTIONS AND RESIDENTS' PARKING ORDER 2006
(AMENDMENT No. 10) Order 2008

1. The Council of the Borough of Slough, in exercise of the powers conferred on it under Sections 1, 2, 4, 124 and parts III and IV of Schedule 9 to the Road Traffic Regulation Act ("the Act") and of all other enabling powers and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-
2. This Order shall come into effect on the 23rd February 2009 and may be cited as "The Borough of Slough Waiting Restrictions and Residents Parking Order 2006 (Amendment No. 10) Order 2008".
3. The Borough of Slough Waiting Restrictions and Residents' Parking Order 2006 shall have effect as though:
 - (a) The items relating to Castle Street and Herschel Street were deleted from Schedule 2.01 of that Order;
 - (b) Schedule 2.01 is amended by the addition of the wording detailed in Schedule A of this Order;
 - (c) The item relating to Herschel Street is deleted from Schedule 3.01 of that Order;
 - (d) Schedule 3.01 is amended by the addition of the wording detailed in Schedule B of this Order;
 - (e) The items relating to Albert Street (eastern arm) and Buckingham Gardens were deleted from Schedule 3.02 of that Order;
 - (f) Schedule 3.02 is amended by the addition of the wording detailed in Schedule C of this Order;
 - (g) Schedule 4.09 is amended by the addition of the wording detailed in Schedule D of this Order;
 - (h) The items relating to Albert Street, Hencroft Street South, Osborne Street were deleted from Schedule 8.02 of that Order;
 - (i) Schedule 8.02 is amended by the addition of the wording detailed in Schedule E of this Order;
 - (j) The items relating to Albert Street, Osborne Street and St Laurence Way were deleted from Schedule 9.02 of that Order; and
 - (k) Schedule 9.02 is amended by the addition of the wording detailed in Schedule F of this Order.

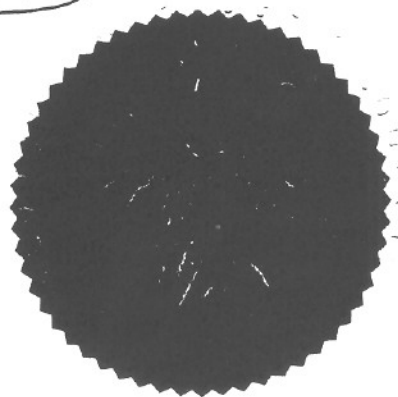
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
