 - (a) The item relating to Brands Road was deleted from Schedule 2.01 of that Order;
 - (b) Schedule 2.01 was amended by the addition of the restrictions referred to in Schedule A;
 - (c) The item relating to Brands Road was deleted from Schedule 3.01 of that Order;
 - (d) Schedule 3.17 is added to the Order by the inclusion of the restrictions referred to in Schedule B:
 - (e) Schedule 8.01 was amended by the addition of the wording referred to in Schedule C;
 - (f) Schedule 8.02 was amended by the addition of the wording referred to in Schedule D;

THE BOROUGH OF SLOUGH WAITING RESTRICTIONS AND RESIDENTS' PARKING ORDER 2006 (AMENDMENT No. 5) (EXPERIMENTAL) ORDER 2009

STATEMENT OF REASONS

This Order introduces a combination of 'No waiting at any time' restrictions, 'No waiting Monday to Friday 8am – 6pm' restrictions and 'Resident permit holder only' parking bays operational at all times, to prevent obstructive parking by contractors vehicles associated with the adjacent redevelopment of the 'Quality Hotel' on London Road in Brands Road.

In addition 'No waiting at any time' restrictions will be introduced in Layburn Crescent and Pepys Close, for a distance of 14 metres and 5 metres respectively, to prevent obstructive parking and improve sight lines at their junctions with Brands Road.

These restrictions are being introduced on an experimental basis for a maximum period of 18 months. The Council will be considering in due course whether the provisions of the Order should be continued in force indefinitely.
